("Cross Country"), and Outlaw Padding Company ("Outlaw") (collectively, the "Objectors"), by and through their undersigned counsel, to the Debtors' Amended Chapter 11 Plan [D.I. 1363] (the "Plan") is hereby withdrawn with respect to the objections II through V, therein, inclusive.
