NOTICE OF THE DISCLOSURE STATEMENT HEARING

PLEASE TAKE NOTICE that (a) on April 1, 2020, the above-captioned debtors and debtors in possession (collectively, the “Debtors”) filed the *Joint Chapter 11 Plan of Reorganization of Windstream Holdings, Inc. et al., Pursuant to Chapter 11 of the Bankruptcy Code* [Docket No. 1631] (as amended from time to time and including all exhibits thereto, the “Plan”) and (b) on April 1, 2020, the Debtors filed the *Disclosure Statement for the Joint Chapter 11 Plan of Reorganization of Windstream Holdings, Inc. et al., Pursuant to Chapter 11 of the Bankruptcy Code* [Docket No. 1632] (as amended from time to time and including all exhibits thereto, the “Disclosure Statement”) ² and *Debtors’ Motion to Approve (I) the Adequacy of Information in the Disclosure Statement, (II) Solicitation and Notice Procedures, (III) Forms of Ballots and Notices in Connection Therewith, and (IV) Certain Dates with Respect Thereto* [Docket No. 1633] (the “Disclosure Statement Motion”).
