LIMITED OBJECTION OF GTT AMERICAS LLC and GC PIVOTAL LLC TO CONFIRMATION OF PLAN AND CURE OF EXECUTORY CONTRACTS

GTT Americas LLC and GC Pivotal LLC (jointly, "GTT") for themselves, their affiliates and predecessors in interest, objects to the designation of cure amount listed in the Debtors' Plan Supplement [Dkt. 1973, "Notice of Filing of Plan Supplement"]¹ and in support thereof, avers as follows:

- 1. GTT is engaged in the business of providing telecommunications and broadband services. GTT is located at Suite 1450, 7900 Tysons One Place, McLean, Virginia 22102.
- 2. Debtors are and have been customers of GTT for several years. At the time of the Debtors' petitions for relief in bankruptcy, Debtors were indebted to GTT for telecommunication

This objection is limited to the calculation and payment of cure and is asserted to assure that contracts are assumed subject to all of their terms and obligations as required by §365 without release of said rights by confirmation.



services, equipment rental, late fees and termination charges in the total amount of \$2,025,457.86 under numerous executory contracts, some of which were identified by the Debtors in their Schedules and Notice of Filing of Plan Supplement, incorporated herein by reference. This debt has not been paid.

3. GTT filed timely proofs of claim ("Claims") in these cases as follows:

Copies of these Proofs of Claim are incorporated by reference.

- 4. The Debtors have never objected to GTT's proofs of claim. The proofs of claim are prima facie valid. Bankr. Rule 3001(f).
- 5. In Debtors' Schedules of Assets and Liabilities, Debtors admitted having contingent and uncontingent liquidated debts to GTT.
- 6. On May 6, 2020, Debtors filed a First Amended Joint Chapter 11 Plan of Reorganization and Amended Disclosure Statement. The Plan provided that Debtors would identify which contracts it was assuming or rejecting in a schedule to be filed later as a part of the Plan Supplement, but in any event, unless a contract was specifically identified as rejected, it would be deemed assumed.
- 7. The Debtors filed the Plan Supplement on June 3, 2020. The Assumption Schedule attached to the Supplement identifies 12 contracts ("Contracts") which the Debtor asserts relate to GTT. The names of the co-parties listed, however (Covad, Reliance, Access

²Debtors consented to allow GTT Americas and GC Pivotal to file consolidated claims. Each consolidated claim breaks out the particular amount, and invoice numbers, pertaining to each Debtor and provides an overall summary. An itemization of these claims would comprise many hundreds of pages and are not attached here.

Point Inc., Transbeam Inc. and "WBS Connect (aka GTT)") do not immediately correlate with the GTT entities which filed proofs of claim in the case, GTT Americas LLC and GC Pivotal LLC, although they may relate to the names of companies previously acquired by GTT.

- 8. The Debtor has expressed its intent to assume all contracts and all contract relationships with GTT in light of the fact that it has informed GTT that GTT's claims are not impaired under the Plan and it has no right to vote on the Plan.
- 9. The Cure Amount for the 12 assumed contracts is listed as "TBD". No information is provided as to how or when that determination will be made. In fact, GTT and Windstream have been in negotiations to determine this amount for several months but have not to date been able to reach an agreement.
- 10. To the extent that other contracts are deemed to be accepted under the Plan, no cure amount is listed for these contracts and no provision exists in the Plan for the determination of a cure amount.
- 11. The Plan provides that all obligations under executory contracts, both pre- and post-petition, are released upon assumption of the executory contracts without any explicit provision for cure of pre- and post-petition obligations, whether or not now due.
- 12. Besides the above pre-petition Claim amount, Windstream is indebted to GTT for past-due charges totaling \$184,357.23 since February 2020, and for current debts incurred but not yet due in the total amount of \$1,063,325.86. Attached as Exhibit 1 is a ledger containing a summary of the invoices, payments and balance due.
- 13. Section 1123(b)(2) provides that a Plan may include provisions for assumption of an executory contract if done in compliance with §365. Section 365 requires that, in order for a debtor to assume a contract, it must cure all prior defaults in full. 11 U.S.C. §365(b)(1)(A). It

makes no distinction between pre- and post-petition defaults. Cure includes not only the unpaid bills for services and goods, but also late fees, interest, termination charges and, where provided, attorneys fees. *In re Crown Books Corp.*, 269 B.R. 12, 15 (Bankr. Del. 2001); *In re Skylark Travel*, 120 B.R. 352, 355 (Bankr. S.D.N.Y. 1990); *In re Entertainment Inc.*, 223 B.R. 141, 150 (Bankr. N.D. Ill., 1998).

- 14. As noted above, Debtors are in default of prepetition payments in the amount of \$2,025,457.86. That amount will be increased by any post-petition obligations that remain unpaid on the Effective Date of the Plan.
- 15. The Plan fails to comply with §1123 because it does not satisfy the cure requirements of §365(b)(1)(A).
- 16. In order to resolve this objection, the Plan Supplement should be modified to 1) identify the pre-petition cure amount of GTT's contracts as \$2,025,457.86 and the post-petition cure amount of \$184,357.23, 2) include the timely payment of current but not-yet-due amounts accrued under the assumed contracts according to contract terms and 3) provide for a reservation of rights as to all co-parties whose contracts are "deemed" assumed under the Plan without a designation of a cure amount to claim and receive payment of cure or other accrued obligations in full as such may later be determined.

RESERVATION OF RIGHTS

17. The Debtors have reserved all rights to withdraw any contract from its list of Assumed Executory Contracts. GTT reserves any and all rights, claims, and defenses it has or may have with regard to its Claims, the Contracts, the Cure Notice, any and all cure claims and cure amounts, and any other motion, application, notice, or other documents filed in this case. GTT reserves its right to supplement this Objection to preserve and assert its rights in connection

with the Contracts, including by filing a further objection to the assumption of any of its

Contracts.

18. Nothing herein shall be interpreted as GTT's consent to assumption of any of its

Contracts other than on the conditions set out herein and all objections and defenses to any

request by the Debtors to assume any of the Contracts are expressly reserved.

WHEREFORE, GTT Communications Inc. respectfully requests this Court to enter an

Order sustaining this Objection and requiring payment of cure to GTT no later than the Effective

Date in the amount of \$2,025,457.86 (plus \$184,357.23 and such other postpetition debts that

may be due and unpaid at that time), and modifying the Plan to reserve the rights of all co-parties

of assumed contracts to the determination and payment of cure amounts whether accrued pre- or

post-petition notwithstanding confirmation of the Plan.
