**STIPULATION AND AGREED ORDER GRANTING PREMIER TRAILER LLC
RELIEF FROM THE AUTOMATIC STAY REGARDING COMMERCIAL TRAILERS**

This Stipulation and Agreed Order (“Stipulation and Agreed Order”) is made and entered into by and between Zachry Industrial, Inc. (the “Debtor”) and Premier Trailers, LLC (“Premier”) and together with the Debtor, the “Parties”). The Parties hereby stipulate and agree as follows:

RECITALS

WHEREAS, on May 21, 2024 (the “Petition Date”), the Debtor and a number of its affiliates filed voluntary petitions for relief under chapter 11 of the Bankruptcy Code.

WHEREAS, prior to the Petition Date, the Debtor acted as general contractor for the GPX Project. In connection with the GPX Project, Premier supplied approximately 339 trailers (collectively, the “Trailers”) to Gulf States Trucking Inc. (“Gulf States”) pursuant to applicable rental agreements and Terms and Conditions (collectively, the “Terms”). In turn, Premier provided the Trailers for work at the GPX Project, and upon information and belief the Trailers are still in use at the GPX Project.

WHEREAS, the Debtor is not a party to the Terms, however, the Trailers remain on the GPX Project site.

WHEREAS, the Parties desire to enter into this Stipulation and Agreed Order to permit, but not require, Premier to recover the Trailers from the GPX Project.


NOW, THEREFORE, IT IS HEREBY STIPULATED, AGREED, AND ORDERED:

1. The automatic stay afforded the Debtor pursuant to Section 362(a) of the Bankruptcy Code is hereby terminated, to the extent applicable, so as to permit, but not require, Premier to enforce its interest in the Trailers consistent with the Terms and state or other applicable law, including but not limited to its right to exercise any remedies available to it, consistent with the Terms or state or other applicable law. Given the Debtors' demobilization from the GPX Project as of August 26, 2024, the Debtors shall have no obligation to assist with the removal of any Trailers from the GPX Project site, and no claims related to the removal of any such Trailers shall arise against the Debtors. Further, neither Golden Pass LNG Terminal LLC ("Golden Pass") nor CB&I LLC ("CB&I") nor CCZJV shall have any obligation to assist with the removal of any Trailers from the GPX Project site, and no claims related to the removal of any such Trailers shall arise against Golden Pass, CB&I, or CCZJV. Upon written notice from Premier (which may include notice via email), Golden Pass, CB&I, and CCZJV shall provide reasonable access to the GPX Project site to allow for the removal of the Trailers consistent with applicable agreement or law.

2. Premier agrees that it will not seek to enforce any rights with respect to the Trailers for a period of at least fourteen (14) days following entry of this Stipulation and Agreed Order, and will further provide Golden Pass, CB&I, and CCZJV written notice (which may include notice via email) at least five (5) calendar days before exercising any such rights. For the avoidance of doubt, nothing herein waives, releases, or prejudices any rights, claims, defenses, or interests of Golden Pass, CB&I, or CCZJV under applicable agreement or law.

3. This Court retains exclusive jurisdiction with respect to all matters arising from or related to the implementation, interpretation, and enforcement of this Stipulation and Agreed Order.
