SierraConstellation Partners, LLC ("SCP" or the "Applicant") hereby submits its second interim and final fee application (the "Application") seeking (a) the allowance of fees in the amount of \$26,678.00 for the period from September 1, 2022 through and including December 7, 2022 (the "Second Interim Period"), for total compensation in the amount of \$26,678.00, (b) the allowance of fees in the amount of \$231,959.00 for the period from June 1, 2022 through and including December 7, 2022 (the "Final Period") and (c) payment of the unpaid portion of the compensation for services rendered by SCP during the Second Interim Period and Final Period. In support of the Application, SCP respectfully represents as follows:

Statement of Jurisdiction

1. This Court has jurisdiction to hear the Application pursuant to the provisions of 28 U.S.C. §§ 157 and 1334. Venue is proper in this district pursuant to 28 U.S.C. § 1408. This proceeding involves the administration of the estate and is a core proceeding pursuant to 28 U.S.C. § 157(b)(2)(A) and (B).

2. The predicates for the relief requested herein are: (a) sections 330 and 331 of title 11 of the United States Code §§ 101, et seq. (the "Bankruptcy Code"); (b) Rule 2016 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"); (c) Rule 2016-2 of the Local Rules of Bankruptcy Practice and Procedure of the United States Bankruptcy Court for the District of Delaware (the "Local Rules"); and (d) the Court's Order Establishing Procedures for Monthly, Interim, and Final Compensation and Reimbursement of Expenses of Professionals Retained in this Chapter 11 Case [Docket No. 100] (the "Interim Compensation Order"), entered June 30, 2022 ((a) through (d) are collectively referred to herein as the "Guidelines").

Procedural History

A. Background

- 1. On June 1, 2022 (the "<u>Petition Date</u>"), the Debtor commenced this case (the "<u>Chapter 11 Case</u>") by filing a voluntary petition for relief under chapter 11 of the Bankruptcy Code in the United States Bankruptcy Court for the District of Delaware (the "<u>Court</u>").
- 2. The Debtor has continued in possession of its property and is operating and managing its business as debtor-in-possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code.
- 3. No request has been made for the appointment of an examiner and no committee has been appointed. On June 22, 2022, Patheon Manufacturing Services filed the *Motion of Patheon Manufacturing Services LLC to Convert Chapter 11 Case to Chapter 7* [Docket No. 65], which motion has been adjourned.
 - 4. On June 30, 2022, the Court entered its Interim Compensation Order.³

Beginning on September 10, 2022, SCP filed and served on the relevant notice parties monthly fee applications (the "Monthly Fee Applications") consisting of a brief statement as to the fees and costs incurred in the prior month, including the associated detailed time entries, pursuant to the procedures set forth in the Interim Compensation Order. This Application incorporates by reference the First, Second, Third, Fourth and Fifth

B. Retention of SCP as Financial Advisor to Debtor

- 5. On June 1, 2022, the Debtor retained SCP as its proposed financial advisor in this Chapter 11 Case.
- 6. On June 8, 2022, the Debtor submitted its Application of the Debtor for Entry of an Order Authorizing the Employment and Retention of SierraConstellation Partners, LLC as Financial Advisor for the Debtor Effective as of The Petition Date [Docket No. 40] (the "Retention Application"). On July 7, 2022, the Court entered an order [Docket No. 120] granting the Retention Application and authorizing the employment and retention of SCP as financial advisor to the Debtor effective as of June 1, 2022.

C. SCP's Monthly and Interim Fee Applications

- 7. On September 10, 2022, SCP filed its first Monthly Fee Application for the period spanning from June 1, 2022 through and including June 30, 2022 [Docket No. 189] (the "<u>First Monthly Fee Application</u>"). On October 8, 2022, SCP filed a certificate of no objection to the Fist Monthly Fee Application [Docket No. 228].
- 8. On September 10, 2022, SCP filed its second Monthly Fee Application for the period spanning from July 1, 2022 through and including July 31, 2022 [Docket No. 190] (the "Second Monthly Fee Application"). On October 8, 2022, SCP filed a certificate of no objection to the Second Monthly Fee Application [Docket No. 229].
- 9. On September 10, 2022, SCP filed its third Monthly Fee Application for the period spanning from August 1, 2022 through and including August 31, 2022 [Docket No. 191] (the "Third Monthly Fee Application"). On October 8, 2022, SCP filed a certificate of no objection to the Third Monthly Fee Application [Docket No. 230].

Monthly Fee Applications submitted for June 2022, July 2022, August 2022, September 2022 and October 2022.

- 10. On November 3, 2022, SCP filed the First Interim Application of SierraConstellation Partners, LLC as Financial Advisers to the Debtors for the period June 1, 2022 to August 31, 2022 [Docket No. 259] (the "First Interim Fee Application").
- 11. The Court entered the *Omnibus Order Approving Interim Fee Applications of Professionals* [Docket No. 302] pursuant to which, inter alia, it approved the First Interim Fee Application.
- 12. On November 28, 2022, SCP filed its fourth Monthly Fee Application for the period spanning from September 1, 2022 through and including September 30, 2022 [Docket No. 296] (the "Fourth Monthly Fee Application"). On December 20, 2022, SCP filed a certificate of no objection to the Fourth Monthly Fee Application [Docket No. 320].
- 13. On November 28, 2022, SCP filed its fifth Monthly Fee Application for the period spanning from October 1, 2022 through and including October 31, 2022 [Docket No. 297] (the "Fifth Monthly Fee Application"). On December 20, 2022, SCP filed a certificate of no objection to the Fifth Monthly Fee Application [Docket No. 321].
- 14. Pursuant to this Application, SCP seeks interim approval of fees in the amount of \$26,678.00 for the Second Interim Fee Period. During the Second Interim Fee Period, SCP professionals rendered 61.5 hours of services in the course of representing the Debtor, at a blended rate of \$433.79 per hour.
- 15. Pursuant to this Application, SCP also seeks final approval of fees in the amount of \$231,959.00 for the Final Period. During the Final Period, SCP professionals rendered 524.4 hours of services in the course of representing the Debtor, at a blended, and discounted, rate of \$442.33 per hour.

Services Rendered During the Second Interim and Final Period

- 16. This Application is the second interim and final fee application filed by SCP in this Chapter 11 Case. In connection with the professional services described below, by this Application, SCP seeks compensation (i) in the amount of \$26,678.00 for the Second Interim Fee Period and (ii) in the amount of \$231,959.00 for the Final Period.
- 17. Each of the following for the Second Interim Fee Period is set forth in the invoices attached hereto as "Exhibit A": (i) a description of the professional or paraprofessional performing the services; (ii) the date the services were performed; (iii) a detailed description of the nature of the services and the related time expended; and (iv) a summary of the fees and hours of each professional and other timekeepers listed by project category:⁴

Valuation of Services

- 18. SCP expended a total of 61.5 hours in connection with this matter during the Second Interim Fee Period, and a total of 524.4 hours in connection with this matter during the Final Period. The nature of the work performed by the professionals is detailed in the exhibits to Monthly Fee Applications.
- 19. The hourly rates are SCP's normal hourly rates for work of this character. The reasonable value of the services rendered by SCP to the Debtor during the Second Interim Fee Period, as discounted, is \$26,678.00, and during the Final Period is \$231,959.00.
- 20. In accordance with the factors expressed in section 330 of the Bankruptcy Code, the amounts requested herein for compensation and expense reimbursement are fair and reasonable given: (a) the complexity of this Chapter 11 Case, (b) the time expended by the

22. SCP has provided a copy of this Application to the Notice Parties (as defined in paragraph of the Interim Compensation Order).

Conclusion

WHEREFORE, SCP respectfully requests that (a) it be allowed compensation in the amount of \$21,678.00 for professional services rendered for the Second Interim Fee Period; (b) it be allowed compensation in the amount of \$231,959.00 for professional services rendered for the Final Period; (c) the Court authorize the Debtor to pay SCP any unpaid portion for the Second Interim Fee Period and/or Final Period; and (d) the Court grant such other and further relief deemed appropriate under the circumstances.
