**PLEASE TAKE NOTICE** that on September 25, 2020, the United States Bankruptcy Court for the Southern District of New York (the “**Bankruptcy Court**”) entered an order [Docket No. 879] confirming the *First Amended Joint Chapter 11 Plan of Distribution of JCK Legacy Company and Its Affiliated Debtors and Debtors in Possession* [Docket No. 867, Exhibit A] (as may be modified, supplemented, restated, and further amended from time to time, the “**Plan**”).<sup>2</sup>

**PLEASE TAKE FURTHER NOTICE** that the effective date of the Plan occurred on September 30, 2020 (the “**Effective Date**”).

**PLEASE TAKE FURTHER NOTICE** that the Plan Administration Trustee filed the *Notice of Certification of Dissolution of Certain Debtors* on February 16, 2021 [Docket No. 1121], certifying the dissolution of certain Debtors listed therein.

**PLEASE TAKE FURTHER NOTICE** that pursuant to Article 6.10 of the Plan, Sean M. Harding, a Senior Managing Director with FTI Consulting, Inc. and the Plan Administration Trustee (the “**Plan Administration Trustee**”) for JCK Legacy Company and certain of its affiliates (collectively, the “**Debtors**”), with the consent of the GUC Recovery Trustee, hereby files this certification with the Bankruptcy Court that the Plan Administration Trustee has substantially administered the Plan for the Debtors listed on **Exhibit A** attached hereto (the “**Dissolved Debtors**”).<sup>3</sup>

**PLEASE TAKE FURTHER NOTICE** that the Dissolved Debtors shall be deemed dissolved effective as of December 27, 2020 without further order of the Bankruptcy
