**ORDER GRANTING MOTION FOR JOINT ADMINISTRATION**

THIS CAUSE came before the Court on the motions of the above-captioned debtors and debtors and debtors-in-possession (collectively, the “**Debtors**”)<sup>1</sup>, requesting the Court to permit joint administration of their Chapter 11 cases pursuant to Federal Rule of Bankruptcy Procedure 1015 (the “**Motion**”). Having considered the matter, the Court finds that joint handling of purely administrative matters may aid in expediting the Debtors’ cases and rendering the process less costly, which is contemplated by Bankruptcy Rule 1015. See Advisory Committee Note to Bankruptcy Rule 1015.

Accordingly, it is hereby ORDERED as follows:

1. The Motion is GRANTED.
