5 **CLASS ACTION COMPLAINT FOR, INTER ALIA, VIOLATIONS OF STATE**  
6 **AND FEDERAL SECURITIES LAWS**

7 Plaintiffs, Putative Class Representatives WALDEMARA MARTIN and LEANDRO  
8 VALENTIM, on behalf of themselves and all others similarly situated (hereafter "Plaintiffs")  
9 bring this class action against Defendants TELEXFREE, INC., f/k/a COMMON CENTS  
10 COMMUNICATIONS, INC., TELEXFREE, LLC, TELEXFREE FINANCIAL, INC.,  
11 TELEXELECTRIC, LLLP, TELEX MOBILE, HOLDINGS, INC., (collectively referred to  
12 herein as "TelexFree") and the other named Defendants and Doe Defendants.

13 **INTRODUCTION**

14 1. Plaintiffs seek compensation for economic loss sustained as a result of  
15 Defendants' conduct in carrying out an unlawful Ponzi pyramid scheme that included, *inter alia*,  
16 Defendants' fraudulent unregistered offer and sale of securities in the form of unregistered  
17 investment contracts constituting securities.

18 2. During all times relevant to this complaint, TelexFree uniformly held itself out as  
19 a "multi-level marketing" company systematically selling local and international telephone  
20 service plans that use "voice over internet protocol" ("VoIP") technology through so-called  
21 "Promoters."<sup>1</sup>

22 3. The TelexFree VoIP was not patented or proprietary.

23 4. The TelexFree VoIp offered nothing more than what was otherwise available for  
24 free through other Internet providers such as Skype.

25 5. In reality, TelexFree's offer and sale of investment contracts constituted a  
26 pyramid-type Ponzi scheme (the "Pyramid Ponzi Scheme").

1           6. To carry out their unlawful enterprise, TelexFree and their officers, agents,  
2 servants and employees sold fraudulent unregistered securities to the Putative Class  
3 Representatives and to the members of the class the Representatives seek to represent.

4           7. Telexfree sold unregistered securities in twenty-one states and internationally  
5 from its offices in Marlborough, Massachusetts.<sup>2</sup>

6           8. TelexFree also maintained a post office box in an unnamed mini mart and smoke  
7 shop located in a strip mall in Las Vegas, Nevada.

8           9. TelexFree maintained no sales force or sales support in Nevada at any time  
9 relevant to the complaint.

10          10. The contract under which TelexFree claims to invoke the application of Nevada  
11 law is illegal and void as a matter of law.

12          11. TelexFree's unregistered securities were deceptively and uniformly identified to  
13 members of the putative class as "memberships."

14          12. TelexFree guaranteed returns of 200% or more per year.

15          13. In exchange for copying and placing duplicative and pre-written TelexFree ads on  
16 internet sites – a passive process that alone generates no revenue and requires essentially no  
17 effort on the part of the investors – and for recruiting other investors to pay the membership fees,  
18 TelexFree falsely held out that its investors, or "Promoters," could receive significant returns of  
19 over 200% annually.

20          14. TelexFree uniformly and systematically did not require Promoters to sell its VoIP  
21 product in order to qualify for payments prior to March 9, 2014.

1 15. TelexFree's scheme constitutes an unlawful pyramid scheme because the  
2 proceeds from the sale of TelexFree's VoIP product alone could not sustain the massive pay  
3 structure.

4 16. To keep TelexFree's Pyramid Ponzi Scheme liquid, a constant influx of new  
5 participants was required.

6 17. On June 19, 2013, the Brazilian Court in Acre issued an injunction putting "a stop  
7 to TelexFree's business operations, including the registration of new affiliate investors,  
8 acceptance of new investments and paying any returns owed on existing affiliate investments."<sup>3</sup>

9 18. At all times material herein, TelexFree and its Officers James M. Merrill, Carlos  
10 N. Wanzeler, Steven M. Labriola, Carlos Costa, Joseph H. Craft, a/k/a Joe H. Craft (collectively,  
11 "Defendant Officers"), the Doe Insider Promoters, the Doe Paralegal, TelexFree's Retained  
12 Licensed Professionals<sup>4</sup>, and Payment Processing Services Companies<sup>5</sup> knew that the Pyramid  
13 Ponzi Scheme was not sustainable, and that the representations on Telefree's website and in its  
14 marketing materials were false, unfair, and deceptive including, but not limited to, those  
15 concerning the guaranteed returns.

16 19. Moreover, at all times material herein, TelexFree and its Defendant Officers, the  
17 Doe Inside Promoters, Paralegal Doe, its banks, and its Retained Licensed Professionals knew  
18 that TelexFree was selling unregistered securities to the members of the putative classes.

19 20. Moreover, after the foregoing Defendant Officers, Doe Inside Promoters, Doe  
20 Paralegal, Banks, Payment Processing Services Companies, Retained Licensed Professionals  
21 knew that TelexFree was an illegal pyramid-type Ponzi scheme which involved the illegal sale of  
22 securities, they continued to aid, abet and further such illegal activities.

1 21. Despite the foregoing knowledge, TelexFree and the other Defendants continued  
2 to participate in the attraction and processing of new investors, continued to allow payments to  
3 process through TelexFree's accounts, allowed TelexFree to continue to illegally sell securities  
4 and further its illegal Pyramid Ponzi Scheme, and otherwise continued to further TelexFree's  
5 illegal activities.

6 22. On April 14, 2014, the Defendants TelexFree, Inc., TelexFree, LLC and  
7 TelexFree Financial, Inc. abruptly sought bankruptcy protection in Nevada under Chapter 11,  
8 admitting that they could not and cannot meet their obligations from VoIP revenues and seeking  
9 authority to reject all their current obligations to Promoters.

10 23. At all material times herein, Defendants have violated, *inter alia*, the antifraud  
11 and securities registration provisions of the federal and state securities laws.

12 24. At all material times herein and from at least in or about January 2012 , TelexFree  
13 and the other Defendants unlawfully, willfully and knowingly used the means and  
14 instrumentalities of interstate commerce and the mails, directly and indirectly, in connection with  
15 the purchase and sale of unregistered securities.

16 25. TelexFree and the other Defendants used and employed manipulative and  
17 deceptive devices and contrivances in violation of MGL 110A, Sec. 410; used means and  
18 instrumentalities, directly and indirectly, in connection with the purchase and sale of unregistered  
19 securities; and used and employed manipulative and deceptive devices and contrivances in  
20 violation of, *inter alia*, the Massachusetts Uniform Securities Act, MGL c. 110A, Section 410b,  
21 MGL 110A, Sec. 410(b) and MGL 93A.

22 26. TelexFree and the other Defendants also violated Title 17, Code of Federal  
23 Regulations, Section 240.10b-5 by (a) employing devices, schemes, and artifices to defraud; (b)  
24 making untrue statements of material facts and omitting to state material facts necessary in order  
25 to make the statements made, in the light of the circumstances under which they were made, not  
26 misleading, and (c) engaging in acts, practices, and courses of business which operated and  
27 would operate as a fraud and deceit upon persons.

28

1 27. TelexFree and the other Defendants willfully or knowingly established a pyramid-  
2 type Ponzi scheme by paying certain investors purported returns on investment.

3 28. Making use of this sophisticated pyramid scheme, TelexFree defrauded the  
4 members of the putative class out of funds exceeding \$300,000,000.00 dollars in just a few short  
5 years.

6 29. Certain Defendants share joint and severable liability, including the Doe Inside  
7 Promoters, the licensed professionals such as the RLP Defendants, including certified public  
8 accountants and lawyers that specialized in sheltering so-called Multi-Level Marketing schemes  
9 having aided and abetted TelexFree's Pyramid Ponzi Scheme by providing TelexFree with legal  
10 and financial advice and assistance during the course of the fraud, despite knowledge of the  
11 fraudulent nature of TelexFree's operation.

12 30. The Payment Processing Services Companies and bank Defendants also share  
13 joint and several liability having aided and abetted the fraudulent and illegal activity by  
14 providing financial and payment processing services, also having knowledge of TelexFree's  
15 fraud.

16 31. Plaintiffs also make the following allegations upon information and belief and the  
17 investigation of their counsel, except as to their own actions and the facts that are a matter of  
18 public record:

19 **JURISDICTION AND VENUE**

20 32. This Court has jurisdiction as to the claims for relief sought herein under 28  
21 U.S.C. §§ 157 and 1334, and Rule 1001(b)(2) of the Local Rules of Practice for the United  
22 States District Court for the State of Nevada.

23 33. Venue is proper pursuant to 28 U.S.C. § 1409(a).

24 34. Certain of the claims for relief set forth herein are core proceedings pursuant  
25 to 28 U.S.C. § 157(b)(2)(A) and (O). To the extent the claims for relief set forth herein are  
26 not core proceedings, Plaintiffs do not consent to entry of final judgment by the bankruptcy  
27 court.

28

1 35. The District Court has original jurisdiction pursuant to 28 U.S.C. § 1332(d)(2). In  
2 the aggregate, Plaintiffs' claims and the claims of the other members of the Class exceed  
3 \$5,000,000.00 exclusive of interest and costs, and there are numerous class members who are  
4 citizens of states other than TelexFree, LLC's state of citizenship, which is Nevada.

5 36. Venue is also proper pursuant to 28 U.S.D. § 1391 because:

- 6 a. TelexFree, LLC resides in this district;
- 7 b. acts and transactions giving rise to this action occurred in this district;
- 8 c. TelexFree, LLC is subject to personal jurisdiction in this district; and
- 9 d. on April 13, 2014, TelexFree, LLC, TelexFree, Inc. and TelexFree  
10 Financial, Inc. sought bankruptcy protection in this district (See United  
11 States Bankruptcy Court, District of Nevada, Case No.: BK-S-14-12524-  
12 ABL).

13 37. James Merrill, Carlos Wanzeler, Steven Labriola, Carlos Costa, Joseph H. Craft  
14 and others identified as Does conducted the unlawful business of TelexFree, LLC referenced and  
15 detailed in this complaint in Las Vegas, Nevada during all material relevant times herein  
16 beginning on February 15, 2012 through approximately April 2014.

17 38. James Merrill, Carlos Wanzeler, Steven Labriola, Carlos Costa, Joseph H. Craft  
18 and others identified as Does maintained addresses for the unlawful business of TelexFree, Inc.  
19 referenced and detailed in this complaint in the Las Vegas, Nevada office during the period  
20 between February 15, 2012 through approximately April 2014.

21 39. The District Court also has jurisdiction over this action pursuant to Sections  
22 20(b), 20(d)(1) and 22(a) of the Securities Act of 1933 ("Securities Act") [15 U.S.C. §§ 77t(b),  
23 77t(d)(1) & 77v(a)], Sections 21(d)(1), 21(d)(3)(A), 21(e) and 27 of the Securities Exchange Act  
24 of 1934 ("Exchange Act") [15 U.S.C. §§ 78u(d)(1), 78u(d)(3)(A), 78u(e) and 78aa], Section 1121  
25 of the Lanham Act [15 U.S.C. § 1121], and Section 1965 of the Racketeer Influenced and  
26 Corrupt Organizations Act [18 U.S.C. § 1965]. Defendants have, directly or indirectly, made use  
27 of the means of instrumentalities of interstate commerce and of the mails in connection with the  
28 transactions, acts, practices, and courses of business alleged in this complaint.

1 40. Venue is also proper in this district pursuant to Section 22(a) of the Securities Act  
2 [15 U.S.C. § 77v(a)] and Section 27 of the Exchange Act, 15 U.S.C. § 78aa, because certain of  
3 the transactions, acts, practices, and courses of conduct constituting violations of the federal  
4 securities laws occurred within this district. Defendants transacted business and offered and sold  
5 the securities that are the subject of this action to investors in this district.

6 41. Furthermore, venue is proper under Section 1965 of the Racketeer Influenced and  
7 Corrupt Organizations Act [18 U.S.C. § 1965], as the Defendants reside, have agents, or  
8 otherwise transact business material to this Complaint in this district.

9 **THE PARTIES**

10 42. Plaintiff WALDEMARA MARTINS (hereinafter sometimes referred to as  
11 “Martins”), is an individual who resides in Massachusetts. Martins, like many other victims of  
12 TelexFree’s Pyramid Ponzi Scheme, tendered cash in exchange for a membership in TelexFree  
13 (a “TelexFree Membership”) and its promised pre-March 9, 2014 return in investment (the Pre  
14 March 9, 2014 -Return on Investment”).

15 43. Plaintiff LEANDRO VALENTIM (hereinafter sometimes referred to as  
16 “Valentim”) is an individual who resides in Massachusetts. Valentim, like many other victims of  
17 TelexFree’s Pyramid Ponzi Scheme, tendered cash in exchange for a TelexFree Membership and  
18 its promised Post March 9, 2014 -Return in Investment (the Pre March 9, 2014 -Return on  
19 Investment”).

20 44. Defendant TELEXFREE, INC. is a corporation duly organized and existing under  
21 the laws of the Commonwealth of Massachusetts, having a last known principal place of  
22 business at 225 Cedar Hill Street, Suite 200, in Marlborough, County of Middlesex,  
23 Commonwealth of Massachusetts 01752.

24 45. TelexFree, Inc. was formerly known as COMMON CENTS  
25 COMMUNICATIONS, INC.

26 46. Defendant TELEXFREE, LLC is a limited liability company duly organized and  
27 existing under the laws of the state of Nevada, having a purported place of business at 4705 S.  
28 Durango Drive, #100-J51 (a post office box), Las Vegas, Nevada 89147.



1 47. Defendant Paralegal Doe served as TelexFree, LLC's agent, servant or employee  
2 at all times relevant to this complaint.

3 48. At all times material herein, TelexFree, LLC also maintained offices in the  
4 Commonwealth of Massachusetts at 225 Cedar Hill Street, Suite 200, in Marlborough, County of  
5 Middlesex, Commonwealth of Massachusetts 01752 between 2012 and this date.

6 49. Defendant TELEXFREE FINANCIAL, INC. (hereinafter sometimes referred to  
7 as "TelexFree Financial") is a corporation duly organized and existing under the laws of the State  
8 of Florida, having its last known principal place of business at 2321 NW 37<sup>th</sup> Avenue, in  
9 Coconut Creek, Florida 33063.

10 50. Defendant TELEXELECTRIC, LLLP (hereinafter sometimes referred to as  
11 "TelexElectric") is a limited liability limited partnership duly organized and existing under the  
12 laws of the State of Nevada, and having its registered agent as BWFC Processing Center, LLC,  
13 3960 Howard Hughes Parkway, Suite 500, Las Vegas, Nevada 89169.

14 51. Defendant TELEX MOBILE, HOLDINGS, INC. (hereinafter sometimes referred  
15 to as "Telex Mobile") is a corporation duly organized and existing under the laws of the State of  
16 Nevada, and having its registered agent as BWFC Processing Center, LLC, 3960 Howard  
17 Hughes Parkway, Suite 500, Las Vegas, Nevada 89169.

18 52. Defendant JAMES M. MERRILL (hereinafter sometimes referred to as "Merrill")  
19 is an individual now or formerly of 1 Coburn Drive in Ashland, County of Middlesex,  
20 Commonwealth of Massachusetts 01721.

21 53. At all times material herein, Co-Defendant Merrill was President, Secretary, and  
22 Director of TelexFree, Inc.

23 54. At all times material herein, Co-Defendant, Merrill was a Manager of TelexFree,  
24 LLC, and was listed with the Massachusetts Secretary of State Corporations Division as an  
25 authorized person to execute, acknowledge, deliver, and record any recordable instrument  
26 purporting to affect an interest in real property.

27 55. At all times material herein, Co-Defendant Merrill, was President, Secretary, and  
28 Director of TelexFree Financial.

1 56. Defendant CARLOS N. WANZELER (hereinafter sometimes referred to as  
2 "Wanzeler") is an individual now or formerly of 373 Howard Street, in Northborough, County of  
3 Worcester, Commonwealth of Massachusetts 01532.

4 57. At all times material herein, Co-Defendant Wanzeler was Treasurer and Director  
5 of TelexFree, Inc.

6 58. At all times material herein, Co-Defendant Wanzeler was a Manager of  
7 TelexFree, LLC.

8 59. At all times material herein, Co-Defendant Wanzeler was Vice-President,  
9 Treasurer, and Director of TelexFree Financial, and was listed with the Massachusetts Secretary  
10 of State Corporations Division as an authorized person to execute, acknowledge, deliver, and  
11 record any recordable instrument purporting to affect an interest in real property.

12 60. Defendant STEVEN M. LABRIOLA (hereinafter sometimes referred to as  
13 "Labriola") is an individual now or formerly of 21 Kiwanis Beach Road, in Upton, County of  
14 Worcester, Commonwealth of Massachusetts 01568.

15 61. The Articles of Incorporation for Common Cents Communications, Inc. filed with  
16 the Massachusetts Secretary of State's Office identify Labriola as a Director of the Corporation.

17 62. Defendant Labriola functions as the international sales director of TelexFree.

18 63. Defendant JOSEPH H. CRAFT, also known as JOE H. CRAFT, (hereinafter  
19 sometimes referred to as "Craft") is an individual now or formerly of 825 E. Main Street in  
20 Boonville, Indiana 47601-1885.

21 64. Defendant Craft is a Certified Public Accountant and maintains offices in Indiana  
22 and Kentucky under the name and style Joe H. Craft, CPA/PFS, CFP. In Indiana, he maintains  
23 offices at 825 E. Main Street in Boonville, Indiana 47601-1885.

24 65. At all material times herein, Defendant Craft serves as the Chief Financial Officer  
25 of Telex Free, Inc. and TelexFree, LLC, and was responsible for preparing or approving their  
26 financial statements.

27 66. Defendant CRAFT FINANCIAL SOLUTIONS, LLC (hereinafter sometimes  
28 referred to as "Craft Financial") is a limited liability company duly organized and existing under

1 the laws of the state of Indiana, having a principal place of business at 825 E. Main Street in  
2 Boonville, Indiana 47601-1885.

3 67. Defendant Craft Financial is engaged in the business of providing accounting  
4 services and financial advice.

5 68. Defendant Craft is the sole member, manager, and registered agent for the  
6 Defendant Craft Financial, LLC.

7 69. Defendant CARLOS COSTA, (hereinafter sometimes referred to as "Costa") is an  
8 individual now or formerly of 44A McClintock Avenue, Unit A, in Worcester, County of  
9 Worcester, Commonwealth of Massachusetts 01604.

10 70. At all times material herein, Co-Defendant Costa was listed as Manager of  
11 TelexFree, LLC with the Massachusetts Secretary of State Corporations Division.

12 71. Defendant GERALD P. NEHRA (hereinafter sometimes referred to as "Nehra") is  
13 an individual now or formerly of Muskegon, Michigan.

14 72. Defendant Nehra maintains a second place of abode at 2149 Tall Oak Court,  
15 Sarasota, Florida 34232

16 73. Defendant Nehra is an attorney duly licensed to practice law in the State of  
17 Michigan with offices at 1710 Beach Street in Muskegon, Michigan 49441.

18 74. Defendant GERALD P. NEHRA, ATTORNEY AT LAW, PLLC, is a  
19 professional limited liability company engaged in the practice of law and duly organized and  
20 existing under the laws of the state of Michigan, having a principal place of business at 1710  
21 Beach Street in Muskegon, Michigan 49441.

22 75. Defendant Gerald P. Nehra, Attorney at Law, PLLC, is engaged in the practice of  
23 law.

24 76. Defendant Nehra is the sole member, manager and registered agent for the  
25 Defendant Gerald P. Nehra, Attorney at Law, PLLC.

26 77. Defendant RICHARD W. WAAK (hereinafter sometimes referred to as "Waak")  
27 is an individual now or formerly of Muskegon, Michigan.

28

1 78. Defendant Waak is an attorney duly licensed to practice law in the State of  
2 Michigan with offices at 11300 East Shore Drive, Delton, Michigan 49046.

3 79. At all times material herein, Defendant Nehra was engaged in the practice of law  
4 with Co-Defendant Richard W. Waak, under the name LAW OFFICES OF NERHA AND  
5 WAAK.

6 80. Defendant LAW OFFICES OF NERHA AND WAAK had offices at 1710 Beach  
7 Street, Muskegon, Michigan 49441 and 11300 East Shore Drive, Delton, Michigan 49046.

8 81. At all times material herein, Defendant Waak was engaged in the practice of law  
9 with Co-Defendant Nehra, under the name Law Offices of Nehra and Walk, with primary offices  
10 at 11300 East Shore Drive, Delton, Michigan 49046, and secondary offices at 1710 Beach Street,  
11 in Muskegon, Michigan 49441.

12 82. Defendant Waak is the "*Principal Attorney*"<sup>6</sup> of the Law Offices of Nehra and  
13 Walk.

14 83. Defendant RICHARD W. WAAK, ATTORNEY AT LAW, PLLC, is a  
15 professional limited liability company engaged in the practice of law and duly organized and  
16 existing under the laws of the state of Michigan, having a principal place of business at 11300  
17 East Shore Drive, Delton, Michigan 49046.

18 84. Defendant Richard W. Waak, Attorney at Law, PLLC, is engaged in the practice  
19 of law.

20 85. Defendant Waak is the sole member, manager and registered agent of Defendant  
21 Richard W. Waak, Attorney at Law, PLLC.

22 86. The Law Offices of Nehra and Walk is a general partnership between Defendants  
23 Nehra, Waak, Gerald P. Nehra, Attorney at Law, PLLC, and Richard W. Walk, Attorney at Law,  
24 PLLC.

1 87. Defendant TD BANK, N.A. (hereinafter sometimes referred to as “TD Bank”) is  
2 a national banking institution in the United States chartered and supervised by the federal Office  
3 of the Comptroller of the Currency.

4 88. TD Bank has a principal place of business at 15 Broad Street in Boston, County of  
5 Suffolk, Commonwealth of Massachusetts 02109.

6 89. At all times material herein, Defendant TD Bank provided banking services,  
7 maintained accounts, and received transfers of funds for or for the benefit of TelexFree.

8 90. Defendant CITIZENS FINANCIAL GROUP, INC. (hereinafter sometimes  
9 referred to as “Citizens Financial”) is a corporation duly organized and existing under the laws of  
10 the State of Delaware, having its principal offices in Providence, Rhode Island.

11 91. Citizens Financial is a banking institution with offices at 28 State Street, Boston,  
12 County of Suffolk, Commonwealth of Massachusetts 02109.

13 92. At all times material herein, Defendant Citizens Financial provided banking  
14 services, maintained accounts, and received transfers of funds for or for the benefit of TelexFree.

15 93. Defendant CITIZENS BANK OF MASSACHUSETTS (hereinafter sometimes  
16 referred to as “Citizens Bank”) is a subsidiary of Citizens Financial.

17 94. Citizens Bank conducts business in the Commonwealth of Massachusetts at 28  
18 State Street, in Boston, County of Suffolk, Commonwealth of Massachusetts 02109.

19 95. At all times material herein, Defendant Citizens Bank provided banking services,  
20 maintained accounts, and received transfers of funds for or for the benefit of TelexFree.

21 96. Defendant FIDELITY CO-OPERATIVE BANK doing business as FIDELITY  
22 BANK (hereinafter sometimes referred to as “Fidelity Bank”) is a Massachusetts Chartered  
23 Banking Institution, having its principal offices at 675 Main Street, in Fitchburg, County of  
24 Worcester, Commonwealth of Massachusetts 01420.

25 97. At all times material herein, Defendant Fidelity Bank provided banking services,  
26 maintained accounts, and received transfers of funds for or for the benefit of TelexFree.

27 98. Defendant MIDDLESEX SAVINGS BANK (hereinafter sometimes referred to as  
28 “Middlesex Savings”) is a Massachusetts Chartered Banking Institution, having its principal

1 offices at 6 Main Street, in Natick, County of Middlesex, Commonwealth of Massachusetts  
2 01760.

3 99. At all times material herein, Defendant Middlesex Savings provided banking  
4 services, maintained accounts, and received transfers of funds for or for the benefit of TelexFree.

5 100. Defendant GLOBAL PAYROLL GATEWAY, INC. (hereinafter sometimes  
6 referred to as “GPG”) is a corporation duly organized and existing under the laws of the State of  
7 California, having its principal offices at 18662 MacArthur Boulevard, Suite 200, in Irvine,  
8 California 92612.

9 101. Defendant GPG provides payment processing services for companies, and acted  
10 as a conduit for payment between TelexFree and its Promoters/Investors.

11 102. Defendant INTERNATIONAL PAYOUT SYSTEMS, INC. (hereinafter  
12 sometimes referred to as “IPS”) is a corporation duly organized and existing under the laws of  
13 the State of Florida, having its principal offices at 2500 East Hallandale Beach Boulevard, Suite  
14 800, Hallandale Beach, Florida 33009.

15 103. Defendant IPS provides payment processing services for companies and acted as  
16 a conduit for payment between TelexFree and its Promoters/Investors.

17 104. Defendant PROPAY, INC. (hereinafter sometimes referred to as “ProPay”) is a  
18 corporation duly organized and existing under the laws of the State of Utah.

19 105. Defendant ProPay has its principal offices at 3400 North Ashton Boulevard, Lehi,  
20 Utah 84043 and also does business as PROPAY.COM.

21 106. Defendant ProPay provides payment-processing services for companies and acted  
22 as a conduit for payment between TelexFree and its Promoters/Investors.

23 107. It is believed that additional payment – processing services aided and abetted in  
24 TelexFree’s Pyramid Ponzi scheme but their identities are as yet unknown. For ease of reference  
25 at this time they can only be referred to herein at this time as Defendant Payment – Processing  
26 Services Doe.

27  
28

1 108. Disk a Vontade is operated out of a Massachusetts post office box. TelexFree and  
2 Disk a Vontade share key management, and prior to their activities as described herein, they  
3 shared Brazil as a target market.

4 109. Disk a Vontade's domain ("discavontade.com") is registered to Defendant Carlos  
5 Wanzeler.

6 110. Defendant James Merrill has attended Disk a Vontade events, including those  
7 held in Brazil.

8 111. The Putative Class Representatives seek to obtain damages, restitution and  
9 injunctive relief for the Class, as defined below, from Defendants.

10 **GENERAL ALLEGATIONS**

11 **A. TELEXFREE, LLC**

12 112. Telex Free, LLC was organized under the laws of the State of Nevada on July 19,  
13 2012.

14 113. There is no distinction between the business operations of TelexFree, LLC and  
15 TelexFree, Inc.

16 114. At all material times herein, TelexFree LLC was identified as a limited liability  
17 corporation as registered with the Corporations Division of the Secretary to the Commonwealth  
18 of Massachusetts (Identification Number 001105166).

19 115. TelexFree, LLC registered with the Secretary of State for the Commonwealth of  
20 Massachusetts on April 18, 2013.

21 116. At all times material herein, TelexFree, LLC maintained a post office box at 4705  
22 S. Durango Drive, #100-J51, Las Vegas, Nevada 89147.

23 117. At all times material herein, and at least between February 15, 2012 and  
24 approximately April 15, 2014, TelexFree, LLC operated a Massachusetts office at 225 Cedar Hill  
25 St., Suite 200, Marlborough, Massachusetts 01752.

26 118. At all material times herein, Co-Defendants Carlos Costa, James M. Merrill and  
27 Carlos N. Wanzeler were the Managers of TelexFree, LLC.

28

1 119. At all times material herein, and at least between February 15, 2012 and  
2 approximately April 15, 2014, TelexFree, LLC's registered agent for the Commonwealth of  
3 Massachusetts was James Merrill whose address is identified as 225 Cedar Hill St. Suite 200,  
4 Marlborough, MA 01752.

5 120. At all times material herein, and at least between February 15, 2012 and  
6 approximately April 15, 2014, Co-Defendants James Merrill, Carlos Wanzeler, Steven Labriola,  
7 Joseph H. Craft and Carlos Costa conducted the business of TelexFree, LLC in TelexFree's  
8 Massachusetts office.

9 121. TelexFree caused a copy the Business Entity Summary for TelexFree, LLC to  
10 filed with the Corporations Division of the Secretary of the Commonwealth of Massachusetts.

11 122. Since mid-November 2013, TelexFree has transferred approximately \$30  
12 million from its operating accounts to accounts owned and controlled by TelexFree, its  
13 affiliated companies or the individual Defendants.

14 123. Tens of millions of additional investor funds received by TelexFree are  
15 unaccounted for presently.

16 **B. TELEXFREE, INC f/k/a COMMON CENTS COMMUNICATIONS, INC.**

17 124. TelexFree, Inc.<sup>7</sup> is a domestic profit corporation registered with the Corporations  
18 Division of the Secretary to the Commonwealth of Massachusetts (Identification Number  
19 000832397).

20 125. At all times material herein, and at least between February 15, 2012 and  
21 approximately April 15, 2014, TelexFree, Inc. maintained a principal office at 225 Cedar Hill St.  
22 Suite 200, Marlborough, MA 01752.

1 126. Co-Defendants James M. Merrill and Carlos N. Wanzeler are the officers and  
2 directors of TelexFree, Inc.

3 127. At all times material herein, and at least between February 15, 2012 and  
4 approximately April 15, 2014, TelexFree, Inc.'s registered agent was Defendant James Merrill,  
5 who listed an address of 225 Cedar Hill St., Suite 200, Marlborough, MA 01752.

6 128. At all times material herein, and more particularly since February 15, 2012, Co-  
7 Defendants James Merrill, Carlos Wanzeler, Steven Labriola, Joseph H. Craft and Carlos Costa  
8 conducted the business of TelexFree, Inc. in the Marlborough, Massachusetts office

9 129. TelexFree, Inc. was originally organized on December 31, 2002 under the name  
10 Common Cents Communications, Inc. ("CCCI"). CCCI's name was changed to TELEXFREE,  
11 INC on February 15, 2012.

12 130. TelexFree caused a copy of the Business Entity Summary for TelexFree, Inc. as  
13 filed with the Corporations Division of the Secretary of the Commonwealth of Massachusetts.

14 131. TelexFree, Inc. issued 275,000 shares of CNP class stock with a \$0.00 value per  
15 share.

16 **C. TELEXFREE FINANCIAL, INC.**

17 132. TelexFree Financial was incorporated by Co-Defendant Joseph H. Craft on  
18 December 26, 2013.

19 133. TelexFree Financial was fraudulently set up for the purpose of sheltering funds  
20 rightfully belonging to the putative class.

21 134. At all material times herein, Co-Defendants James M. Merrill and Carlos N.  
22 Wanzeler are officers and directors of TelexFree Financial, and Co-Defendant Carlos N.  
23 Wanzeler is its registered agent.

24 135. On December 30 and December 31, 2013, TelexFree Financial received wire  
25 transfers totaling \$4,105,000 from TelexFree, Inc. and TelexFree, LLC.

26 136. On April 14, 2014, Defendants TelexFree, Inc., TeleFree, LLC and TelexFree  
27 Financial, Inc. abruptly sought bankruptcy protection in Nevada under Chapter 11, admitting that  
28

1 they cannot meet their obligations from VoIP revenues, and sought authority to reject all their  
2 current obligations to Promoters.

3 **D. RELATIONSHIP OF TELEXFREE, LLC, TELEXFREE, INC. AND**  
4 **TELEXFREE FINANCIAL, INC.**

5 137. At all times material herein, and at least since February 15, 2012, there has been a  
6 high degree of operational interdependence among TelexFree, LLC, TelexFree, Inc., and  
7 TelexFree Financial, to the extent that the operations of these entities are indistinguishable.

8 138. At all times material herein, TelexFree, LLC, TelexFree, Inc., and TelexFree  
9 Financial shared common management and ownership.

10 139. More particularly, and at all times material herein, and at least since February 15,  
11 2012, Defendants Merrill, Wanzeler, Labriola, Craft and Costa have together owned and  
12 operated TelexFree, LLC, TelexFree, Inc., and TelexFree Financial without any distinction  
13 among these entities.

14 140. At all times material herein, and at least between February 15, 2012 and  
15 approximately April 15, 2014, funds were freely transferred between and among TelexFree,  
16 LLC, TelexFree, Inc., and TelexFree Financial without any distinction among these entities.

17 141. At all times material herein, TelexFree, LLC, TelexFree, Inc. and TelexFree  
18 Financial have also shared common financial, strategic, legal, and human resources.

19 142. More particularly, at all times material herein, and at least between February 15,  
20 2012 and approximately April 15, 2014, TelexFree, LLC, TelexFree, Inc. and TelexFree  
21 Financial:

- 22 a. Conducted business from the same business addresses;
- 23 b. Retained the same employees;
- 24 c. Conducted business using the same telephone lines;
- 25 d. Utilized the same copy machines in the course of business;
- 26 e. Utilized the same banks and bank accounts in the course of business;
- 27 f. Utilized the same payment processing services companies in the course of  
28 business;

- 1 g. Sought and received professional services from the same accountants; and
- 2 h. Sought and received professional services from the same attorneys.

3 143. As such, Defendants TelexFree, LLC, TelexFree, Inc. and TelexFree Financial are  
4 alter ego entities, which combine to form a single enterprise.

5 **E. TELEXFREE’S UNLAWFUL, UNFAIR AND DECEPTIVE PYRAMID PONZI**  
6 **SCHEME**

7 144. In January 2013, the Brazilian Bureau of Consumer Protection (known as  
8 Procon), began an investigation into TelexFree.

9 145. On March 14, 2013, the Ministry of Finance, after its investigation, declared that  
10 The Telexfree business of selling packages of internet telephony  
11 (VoIP, its acronym in English), is not sustainable and suggests a  
12 Ponzi scheme, which is a crime against the popular economy.

12 That is the conclusion of the Secretariat for Economic Monitoring  
13 of the Ministry of Finance (Seae / MF) in a statement on Thursday  
14 (14).<sup>8</sup>

14 146. On March 9, 2014, TelexFree changed its compensation plan, thereby requiring  
15 Promoters to sell its VoIP product to qualify for the payments that TelexFree had previously  
16 promised to pay them.

17 147. TelexFree’s former officers or employees stated to the TelexFree transition team  
18 that under the Pre March 2014 standard form contract TelexFree owes its promoters over \$5  
19 billion dollars.

20 148. Following the March announcement TelexFree investors demanded TelexFree  
21 reimburse them over \$150 million dollars.

22 149. The rule change generated a storm of protests from Promoters who were unable to  
23 recover their money. On April 1, 2014, dozens of Promoters descended upon TelexFree’s  
24 Marlborough, Massachusetts office to protest this change and attempt to regain access to their  
25 money.

26

1 150. In furtherance of their unlawful enterprise, TelexFree mailed fraudulent and  
2 inaccurate 1099 (Miscellaneous Income) forms to investors, possibly to create the illusion that  
3 they had made payments to investors.

4 151. The 1099 forms were provided long after the mandated January 31, 2014  
5 deadline, and some after the April 15, 2014 filing deadline.

6 152. TelexFree falsely represented that investors had received income that they had in  
7 fact never received.

8 153. TelexFree did not generate sufficient funds from sales of their phone service to  
9 pay the returns on investments that they had contracted to pay.

10 154. Instead, the funds TelexFree used to pay the purported returns on investments  
11 were the principal investment funds (membership fees) tendered by subsequent TelexFree  
12 investors.

13 155. TelexFree's Contract at Section 2.6.5 (m) mandates that Promoters are not to use  
14 the term investment with respect to the registration costs.

15 156. Co-Defendant and Company Counsel Attorney Gerald P. Nehra, through his  
16 affiliated companies (Law Offices of Nehra and Waak, Gerald P. Nehra, Attorney at Law, PLLC,  
17 and Richard W. Waak, Attorney at Law, PLLC), and under the direct supervision of Co-  
18 Defendants Richard W. Waak and Richard W. Waak Attorney at Law, PLLC provided this  
19 deceitful advice for the purpose of furthering perpetuating Defendants unlawful Pyramid Ponzi  
20 Scheme.

21 157. Specifically, TelexFree's Contract at Section 2.6.5 (m) specifically provides that  
22 the Promoter must not "use terms that distort the real meaning of products or the mechanism and  
23 functioning of multilevel marketing, including, without limitation, expressions that convey the  
24 idea of instant wealth for nothing in exchange, as well as speaking of registration costs as a  
25 'financial investment.' Similarly, it is expressly prohibited to use the term 'INVESTMENT' at  
26 meetings and in promotional materials in general, orally or in writing."

27 ...

28 ...

1 **F. TELEXELECTRIC, LLLP'S AND TELEX MOBILE HOLDINGS, INC.'S**  
2 **INVOLVEMENT IN THE TELEXFREE PYRAMID PONZI SCHEME**

3 158. TelexElectric is a Nevada limited liability limited partnership formed on  
4 December 2, 2013 by Co-Defendants Merrill and Wanzeler.

5 159. According to its filings with the State of Nevada Secretary of State Office, Co-  
6 Defendants Merrill and Wanzeler are listed as the General Partners of TelexElectric.

7 160. Co-Defendants Merrill and Wanzler further list their address as 4705 S. Durango  
8 Drive, #100-J1 (a post office box), Las Vegas, Nevada 89147, which is the same location as  
9 TelexFree, LLC.

10 161. TelexElectric also lists as its address 4705 S. Durango Drive, #100-J1 (a post  
11 office box), Las Vegas, Nevada 89147.

12 162. Telex Mobile is a Nevada corporation formed on November 26, 2013.

13 163. According to its filings with the State of Nevada Secretary of State Office, Telex  
14 Mobile identifies its officers and directors as:

15 i. Co-Defendant James M. Merrill is President, Secretary and Director,  
16 having an address at 4705 S. Durango Drive, #100-J1 (a post office box),  
17 Las Vegas, Nevada 89147.

18 j. Co-Defendant Carlos Wanzeler is Treasurer and Director, having an  
19 address at 4705 S. Durango Drive, #100-J1 (a post office box), Las Vegas,  
20 Nevada 89147.

21 164. According to filings with the State of Nevada Secretary of State Office, both  
22 TelexElectric and Telex Mobile Holdings identify as their registered agent BWFC Processing  
23 Center, LLC, 3960 Howard Hughes Parkway, Suite 500, Las Vegas, Nevada 89169

24 165. Defendants TelexFree, LLC, TelexFree, Inc., TelexFree Financial, TelexElectric  
25 and TelexFree Mobile Holdings are alter ego entities, which combine to form a single enterprise.

26 166. TelexFree's financial statements reveal that TelexFree Electric received a  
27 \$2,022,329.00 "loan" from TelexFree during the class period.

28

1 167. TelexFree's financial statements further reveal that TelexFree Mobile received a  
2 \$500,870 "loan" from TelexFree during the class period.

3 168. TelexElectric was fraudulently set up for the purpose of sheltering funds  
4 rightfully belonging to the putative class.

5 169. These "loans" were in essence fraudulent transfers by TelexFree to evade claims  
6 by investors and creditors, and otherwise to unlawfully abscond with funds that rightfully  
7 belonged to creditors and investors.

8 **G. TELEXFREE'S MANAGEMENT KNOWINGLY PERPETRATED THE**  
9 **UNLAWFUL TELEXFREE PYRAMID PONZI SCHEME AND CONSPIRACY**

10 170. At all times material herein, Defendants Merrill, Wanzeler, Labriola, Craft and  
11 Costa (hereinafter sometimes collectively "TelexFree's Management") were responsible for the  
12 control and operation of TelexFree and its affiliated entities.

13 171. Moreover, TelexFree's Management not only controlled the activities and  
14 operations of TelexFree, but also knowingly and willfully conspired to perpetrate, and did in fact  
15 perpetrate, the TelexFree Pyramid Ponzi Scheme with full awareness of its fraudulent and illegal  
16 nature.

17 172. At all times material herein, Defendant Merrill served as the President, Secretary,  
18 and Director of TelexFree, Inc., a Manager of TelexFree, LLC, President, Secretary and Director  
19 of TelexFree Financial, General Partner of TelexElectric, and President, Secretary and Director  
20 of Telex Mobile Holdings

21 173. In his capacities as Officer, Director, Manager and General Partner of the  
22 foregoing interrelated companies, Merrill exercised significant control over TelexFree's business  
23 operations.

24 174. More particularly, Merrill exercised significant control over the TelexFree  
25 Pyramid Ponzi Scheme.

26 175. Defendant Merrill has appeared in videos posted to the internet, in which he can  
27 be seen promoting TelexFree as a revenue opportunity for Promoters.  
28

1 176. As of March 28, 2014, the TelexFree website included a biography of Merrill,  
2 which stated that Merrill was a 1985 graduate of Westfield State University in economics.

3 177. Also, as of March 28, 2013, the TelexFree website stated that Merrill is “well  
4 versed in one of the new technologies of the era (VoiP) [sic].”

5 178. As of April 28, 2014, the TelexFree Canadian website<sup>9</sup> continued to state that  
6 Merrill is a 1985 graduate of Westfield State University in economics and “[k]nowledgeable  
7 about a new era of technology (VOIP).”

8 179. According to testimony obtained by the Office of the Secretary of the  
9 Commonwealth of Massachusetts (hereinafter sometimes referred to as “SOC”), Merrill attended  
10 Westfield State University for a mere two years, without either receiving a degree or declaring a  
11 major.

12 180. Furthermore, in direct contravention to the representations of the TelexFree  
13 websites, Merrill testified to SOC that he had only a basic understanding of VoIP technology.

14 181. At all times material herein, Defendant Wanzeler served as Treasurer and a  
15 Director of TelexFree, Inc., a Manager of TelexFree, LLC, Vice President, Treasurer, and a  
16 Director of TelexFree Financial, General Partner of TelexElectric and Treasurer and Director of  
17 Telex Mobile Holdings.

18 182. According to corporate filings on record with SOC, at all times material herein,  
19 Wanzeler has also served as the Chief Executive Officer of TelexFree, Inc.

20 183. In his capacities as Officer, Director, Manager and General Partner of the  
21 foregoing interrelated companies, Wanzeler exercised significant control over TelexFree’s  
22 business operations.

23 184. More particularly, Wanzeler exercised significant control over the TelexFree  
24 Pyramid Ponzi Scheme.

25  
26  
27

1 185. Defendant Wanzeler has also participated in marketing TelexFree to potential  
2 investors, appearing in videos posted to the Internet in which he can be seen promoting  
3 TelexFree as a revenue opportunity for Promoters.

4 186. At all times material herein, Defendant Labriola, served as the International  
5 Marketing Director for TelexFree, Inc.

6 187. Labriola was one of the original Directors of Common Cents Communications,  
7 Inc., and at all material times herein exercised significant control over TelexFree's business  
8 operations and the operations of its interrelated companies.

9 188. Defendant Labriola has also appeared in several videos promoting TelexFree  
10 which were posted on the internet, and has acted as TelexFree's spokesman to Investors during  
11 post-bankruptcy petition conference calls.

12 189. As a Director of TelexFree, Inc., Defendant Labriola, has exercised significant  
13 control over the TelexFree Pyramid Ponzi Scheme.

14 190. As International Marketing Director for TelexFree, Inc., Labriola has also actively  
15 and knowingly perpetrated the TelexFree fraud through the dissemination of false and  
16 misleading advertising and marketing communications.

17 191. At all times material herein, Defendant Craft, also known as Joe H. Craft, has  
18 been a certified public accountant and served as the Chief Financial Officer ("CFO") of Telex  
19 Free, Inc and TelexFree, LLC.

20 192. In his capacity as CFO of TelexFree, Craft has been responsible for, *inter*  
21 *alia*, preparing or approving TelexFree's financial statements, overseeing TelexFree's  
22 accounting methods and records, and otherwise exercising significant supervision and control  
23 over TelexFree.

24 193. On April 23, 2013, in response to a request for a profit-and-loss statement issued  
25 by the SOC, TelexFree produced a document purporting to be TelexFree's 2012 profit-and-loss  
26 statement.

27  
28



1 194. TelexFree did not make use of usual and accepted Multi Level marketing  
2 accounting practices. For example they did not separate out income generated by sales of VoIP  
3 from income generated by other means.

4 195. On February 5, 2014, the SOC requested a second profit-and-loss statement from  
5 TelexFree for 2012, which TelexFree produced on February 26, 2014.

6 196. A comparison of these two profit-and-loss statements – each purporting to be  
7 TelexFree’s profit-and-loss statement for 2012 – reveals massive discrepancies.

8 197. For example, the first statement provided by TelexFree lists Total Income for  
9 2012 at \$1,864,939.70, while the second lists Total Income for 2012 at \$2,834,835.70.

10 198. As further examples, Agent Commission is listed at \$520,582.95 in the first,  
11 versus \$2,105,925.61 in the second; Total Expenses are listed as \$784,899.22 in the first, versus  
12 \$2,333,893.09 in the second; Net Operating Income is listed as \$1,080,040.48 in the first, versus  
13 \$478,251.56 in the second; and Net Income is listed as \$1,066,313.39 in the first, versus  
14 \$477,652.23 in the second.

15 199. The existence of duplicative accounting records containing egregious  
16 discrepancies is clear indicia of TelexFree’s falsification of accounting records and failure to  
17 adhere to Generally Accepted Accounting Principals (“GAAP”).

18 200. As Chief Financial Officer for TelexFree, Inc. and TelexFree, LLC, as well as a  
19 certified public accountant, Defendant Craft, knowingly perpetrated the TelexFree fraud by, *inter*  
20 *alia*:

- 21 a. Overseeing TelexFree’s creation of falsified accounting records;
- 22 b. Failing to ensure that GAAP accounting methods were adopted and  
23 adhered to;
- 24 c. Fraudulently certifying TelexFree’s business operations and accounting  
25 practices as good and lawful, despite actual knowledge of their unlawful  
26 and illegitimate nature;
- 27 d. Concealing the fact that the AdCentral Packages purveyed by TelexFree  
28 were actually securities; and

1 e. Concealing and absconding with investor assets.

2 201. At all times material herein, Defendant Costa, was listed as Manager of  
3 TelexFree, LLC with the Massachusetts Secretary of State Corporations Division.

4 202. Costa is one of the original founders of TelexFree.

5 203. At all times material herein, Costa was involved in the day-to-day management  
6 and oversight of TelexFree and was actively involved in and managed its Brazilian operations.

7 204. Costa has appeared on numerous websites and videos posted on the Internet  
8 promoting TelexFree and touting its huge financial return.

9 205. Costa was an outspoken advocate against the Brazilian Court's decision to enjoin  
10 TelexFree's Brazilian activities, and publicly supported TelexFree's illegal and corrupt activities.

11 206. Costa is videoed displaying an Insurance Notification representing that it was  
12 proof of coverage for investors' returns; however, in actuality the document was a notification  
13 denying coverage. (See <http://www.youtube.com/watch?v=q2A2IsAPd0I>).

14 **H. TELEXFREE'S LAWYERS AIDED, ABBETTED AND PLAYED AN**  
15 **INTERGRAL PART IN TELEXFREE'S UNLAWFUL, UNFAIR AND**  
16 **DECEPTIVE PYRAMID PONZI SCHEME**

17 207. Defendants Gerald P. Nehra and Richard W. Waak, along with the entities Law  
18 Offices of Nehra and Waak, Gerald P. Nehra, Attorney at Law, PLLC, and Richard W. Waak,  
19 Attorney at Law, PLLC (hereafter sometimes collectively referred to as "Attorney Defendants")  
20 are self-proclaimed multi-level marketing ("MLM") specialist attorneys. (See, e.g., Nehra  
21 Endorsement at 7:55<sup>10</sup>)

22 208. During the course of TelexFree's fraudulent scheme, the above-named Attorney  
23 Defendants acted as legal counsel to TelexFree.

24

1 209. Attorney Nehra had previously acted as counsel to other multi-level marketing  
2 firms, which were forced, closed by federal and/or state authorities due to fraudulent pyramid  
3 and Ponzi schemes, including Zeek Rewards and AdSurfDaily.<sup>11</sup>

4 210. In fact, during the investigation of the AdSurfDaily scheme, Attorney Nehra filed  
5 an affidavit in court representing that AdSurfDaily was “not a Ponzi Scheme.”<sup>12</sup> Subsequently,  
6 in 2008, AdSurfDaily was forced to cease operations by federal authorities after being found to  
7 be a Ponzi scheme; a fact later admitted to by its principal.<sup>13</sup>

8 211. Attorney Nehra also previously served in an advisory capacity to Zeek Rewards.  
9 Zeek Rewards was later found to be an unlawful Ponzi scheme and was shut down by federal  
10 authorities.

11 212. Attorney Nehra’s extensive experience in multi-level marketing, and particularly  
12 his involvement with the Ponzi schemes involving AdSurfDaily and Zeek Rewards, armed him  
13 with the knowledge of what constitutes violations of United States securities law. Indeed,  
14 Attorney Nehra was well aware that the use of semantics and obscured phraseology to obfuscate  
15 securities laws fails to legitimize TelexFree’s illegal Pyramid Ponzi Scheme.

16 213. Attorney Waak also claims to have more than thirty years of experience in  
17 counseling MLM and direct-selling enterprises.<sup>14</sup>

18 214. Attorney Waak claims to have managed the legal defense of multiple class action  
19 lawsuits involving claims for “pyramiding, securities fraud, false advertising and civil RICO.”

20 215. Attorney Nehra and Attorney Waak are together the general partners of the Law  
21 Offices of Nehra and Waak.

22 216. On the website of the Law Offices of Nerha and Waak, Defendant Attorneys  
23 Nehra and Waak claim to specialize in counseling “domestic and foreign companies operating  
24 MLM (multi-level marketing) businesses in the United States.”<sup>15</sup>

1 217. Also, on the website of the Law Offices of Nerha and Waak, Attorneys Nehra and  
2 Waak boast “No Company that retained this firm BEFORE LAUNCH has been shut down by a  
3 regulator.”<sup>16</sup>

4 218. As general partners of the Law Offices of Nehra and Waak, Attorney Nehra and  
5 Attorney Waak are jointly and severally liable for torts and obligations of the firm.

6 219. During the time that the Law Offices of Nehra and Waak provided legal counsel  
7 to TelexFree, Attorney Waak was Principal Attorney of the law firm.

8 220. During this time, Attorney Waak, as Principal Attorney of the Law Offices of  
9 Nehra and Waak, was charged with oversight of the daily activities of the law firm.

10 221. During this time, Attorneys Nehra and Waak also maintained the Defendant  
11 Professional Limited Liability Companies, Gerald P. Nehra, Attorney at Law, PLLC and Richard  
12 W. Waak, Attorney at Law, PLLC, which, upon information and belief, also provided legal and  
13 counseling services to TelexFree.

14 222. Among the Attorney Defendants, and during the course of TelexFree’s scheme,  
15 there was no clear distinction among the services provided to TelexFree by the Law Offices of  
16 Nehra and Waak, the individual Defendants, and their respective Professional Limited Liability  
17 Companies.

18 223. The Attorney Defendants’ role and involvement in the TelexFree Pyramid Ponzi  
19 Scheme exceeded merely providing legal counsel because they knowingly acted to further and  
20 perpetuate TeleFree’s illegal Pyramid Ponzi Scheme, which caused Plaintiffs Waldemara  
21 Martins and Leandro Valentim and the similarly situated Putative class members to suffer  
22 economic loss.

23 224. The Attorney Defendants had actual knowledge that the TelexFree Business  
24 Model was a fraudulent Pyramid Ponzi Scheme.

25 225. Seeking to personally profit from TelexFree’s exploitation of the members of the  
26 putative class, Defendant Gerald P. Nehra drew upon his prior experience to aid, abet and play

1 an integral part in TelexFree's unlawful, unfair and deceptive acts and practices during times  
2 relevant to this complaint.

3 226. Attorney Nehru counseled TelexFree on methods to evade United States securities  
4 laws that were intended to offer, in part, protection from pyramid Ponzi schemes; all to enrich  
5 himself financially and serve his own selfish interests.

6 227. Attorney Nehra further encouraged TelexFree Investors to unknowingly  
7 participate in the evasion of federal and state securities laws.

8 228. Defendant Nehra accomplished this by representing that his extensive experience  
9 as an MLM expert and his thorough research of TelexFree's business model allowed him to form  
10 a legal opinion that TelexFree was a legitimate business.

11 229. In making this professional opinion Defendant Nehra misrepresented TelexFree  
12 as a legitimate business concern.

13 230. For instance, by instructing Investors to avoid using the terms "investment" with  
14 reference to AdCentral Package (See TeleFree Contract, Paragraph 2.6.5(m)), he attempted to  
15 conceal, and encouraged others to conceal, the fact that TelexFree was involved in the sale of  
16 securities, and further attempted to strip Investors of the rights afforded them by federal and state  
17 securities laws.

18 231. In advising TelexFree Investors to act to avoid the protections offered by federal  
19 and state securities laws, Attorney Nehra never once advised the putative class member  
20 TelexFree Investors that so acting presented a risk to them, including the risk of participating in  
21 an unlawful scheme.

22 232. In advising TelexFree Investors to act to avoid the protections offered by federal  
23 and state securities laws, Attorney Nehra never once advised the putative class member  
24 TelexFree Investors that so acting was against their own interests or that it better served  
25 TelexFree and himself.

26 233. Attorney Nehra's acts of aiding, abetting and playing an integral part in  
27 TelexFree's unlawful, unfair and deceptive acts and practices exceed the scope of zealously  
28 representing TelexFree.

1           234. Defendant Gerald Nehra contributed in an indispensable way to TelexFree's  
2 continued unlawful operation in the United States because, as a duly licensed member of the bar,  
3 he publicly stated to Investors that, in his professional opinion, TelexFree's business model and  
4 operations complied with federal and state laws.

5           235. TelexFree and its Officers knowingly used Attorney Nehra's legal opinions and  
6 misrepresentations as a marketing tool to unfairly and deceptively further and advance their  
7 illegal Pyramid Ponzi Scheme.

8           236. Attorney Nehra knew his legal opinions and representations would be used by  
9 TelexFree as a marketing tool to further and advance their business model.

10           237. Attorney Nehra's opinions were packaged and promoted as part of TelexFree's  
11 total "post Brazilian shut down package" to the members of the putative class.

12           238. As described in greater detail throughout, in the early spring of 2013 TelexFree  
13 Brazil was found to be an illegal pyramid and Ponzi scheme.

14           239. TelexFree suffered a financial crisis when the funds of hundreds of thousands of  
15 Brazilian affiliate investors were frozen in company accounts by order of the Brazilian Court.

16           240. To keep its Pyramid Ponzi Scheme going, TelexFree needed a constant influx of  
17 new investor cash.

18           241. In spring 2013, TelexFree was forced to focus on new markets, including new  
19 Investors from the United States and Canada, because their Brazilian operation had been  
20 shuttered and all Brazilian assets were frozen. To enhance the credibility and marketability of  
21 their United States operation, TelexFree employed the Attorney Defendants as a guise to legalize  
22 their illegal and fraudulent methods, operation and business plan.

23           242. On the weekend of July 26th and 27, 2013, TelexFree held an event, which they  
24 dubbed a "super weekend," in Newport Beach, California. The focus of TelexFree's "super  
25 weekend" event included considerable efforts intended to reassure Investors that its United States  
26 operations and program were legitimate, lawful and worth putting their money behind.

27           243. Notwithstanding the fact that TelexFree's Brazilian bank accounts were frozen  
28 and all their Brazilian recruiting and Return on Investment payments had been suspended by

1 court order in their largest affiliate market, Attorney Nehra advised attendees that the shut-down  
2 in Brazil would have no bearing on TelexFree's U.S. operations.

3 244. At this "super weekend" event, Attorney Nehra spoke at length to attending  
4 investors, assuring them of the legality of TelexFree's operation stating: "It is legally  
5 designed...you are on very solid legal ground," and stating that TelexFree's operation had been  
6 "vetted by the Nehra and Waak law firm."<sup>17</sup>

7 245. In fact when asked by a concerned affiliate about the injunction granted against  
8 the company, Attorney Nehra first deflected its relevance by stating: "Okay, I am the MLM  
9 specialist and attorney for TelexFree in the United States only. So I gotta duck the question."<sup>18</sup>

10 246. Attorney Nehra left no doubt that he and his firm were acting as legal counsel to  
11 TelexFree to assist them in insuring their U.S. operations were lawfully conducted, knowing that,  
12 in fact, these operations were nothing more than an illegal Pyramid Ponzi Scheme.

13 247. Although, at all times material herein, Attorney Nehra emphatically assured  
14 Investors and potential Investors that, in his professional opinion, the TelexFree business model  
15 was legitimate and lawful, he had actual knowledge that TelexFree's operation was unlawful and  
16 illegitimate.

17 248. Furthermore, at all times material herein, Attorney Nehra assured Investors and  
18 potential Investors that, in his professional opinion, the TelexFree business model was  
19 legitimate, although he had actual knowledge that TelexFree Multilevel Marketing Network  
20 "Partnerships"<sup>19</sup> involving TelexFree's AdCentral marketing packages were in fact unregistered

1 securities. Attorney Nehra even provided advice on how to unlawfully circumvent federal and  
2 state securities laws.

3 249. In addition, and at all times material herein, Attorney Nehra assured Investors and  
4 potential Investors that, in his professional opinion, the TelexFree business model was legitimate  
5 and lawful, even though Attorney Nehra had specific knowledge of the ruling of the Brazilian  
6 Court and knowledge of and access to TelexFree's United States operations and their  
7 composition.

8 250. In fact, and more particularly, Attorney Nehra knew that:

- 9 a. TelexFree used the exact same business model in Brazil as they do in the  
10 United States and throughout the world;
- 11 b. The Brazilian court had made a specific finding of fraud and that TelexFree's  
12 United States operations and composition was an unlawful venture;
- 13 c. The Brazilian court described Telex business operations in terms of the  
14 quintessential pyramid scheme after TelexFree's own lawyers unwittingly  
15 admitted as much;
- 16 d. TelexFree's lawyer Djacir Falcão stated to the Brazilian court that if the  
17 injunction continues the company may enter into bankruptcy: "Running the  
18 company really becomes difficult because of the court decision, so we will  
19 appeal," said Falcão<sup>20</sup>;

23 (ADCENTRAL or FAMILY kit) assumes the title of PROMOTER and, as such, receives a space on the site

- 1 e. Falcão tried to appeal to the Brazilian judges on the grounds that “should the
- 2 company spend a few more days being prohibited from signing up new
- 3 investors, they would have no money to pay the old ones;”
- 4 f. A Brazilian judge rejected this argument and denied TelexFree’s injunction
- 5 appeal;
- 6 g. TelexFree’s other appeals were rejected by the Brazilian courts;
- 7 h. One Brazilian judge remarked that the issue is that the earnings will be
- 8 exhausted when the main source of revenue of the group (new affiliate
- 9 registrations) stops;
- 10 i. The above scenario is typically the result of a pyramid scheme;
- 11 j. Judge Samoel Evangelista, 2nd Civil Chamber of the Court of Acre (TJ-AC),
- 12 entered an order to keep the TelexFree funds frozen, to block future payments
- 13 to TelexFree in Brazil and to enjoin TelexFree from signing on new investors
- 14 in Brazil;
- 15 k. According to Brazilian Judge Thais Kalil, how TelexFree earnings are paid
- 16 out was advantageous to the prosecutor’s argument, in that adding publishers
- 17 to the network is of more importance than actually trying to sell the VoIP
- 18 product;
- 19 l. Judge Thais Kalil also wrote that “(t)he issue is that the earnings will be
- 20 exhausted when the main source of revenue of the group (new affiliate
- 21 registrations) stops. Many (affiliates) do not even have the opportunity to
- 22 recover their initial investment (minimum U.S. \$339) and this is detrimental.”

23 251. Defendant Nehra’s own comments make clear that he knew that TelexFree was an  
24 unlawful pyramid Ponzi scheme.

25 252. Defendant Nehra knew at all times relevant to his providing legal opinions and  
26 counsel at the request of TelexFree that TelexFree’s conduct constituted a breach of duty to its  
27 Investors.

28

1           253. Defendant Nehra knew at all times relevant to his providing legal opinions and  
2 counsel at the request of TelexFree that his role was intended to give substantial assistance or  
3 encouragement to TelexFree to continue its unlawful business model.

4           254. Defendant Nehra knew at all times relevant to his providing legal opinions at the  
5 request of TelexFree that TelexFree intended to use Nehra prominently as a marketing tool on  
6 both their localized Brazilian (Portuguese) and Spanish (Spanish) website portals, in an effort to  
7 make TeleFree's illegal Pyramid Ponzi Scheme appear legitimate, thereby continuing and  
8 perpetuating the ongoing fraud.

9           255. TelexFree in fact did, with his knowledge, use Attorney P. Nehra and his legal  
10 opinions supporting their business model as lawful prominently as a marketing tool on both their  
11 localized Brazilian (Portuguese) and Spanish (Spanish) website portals.

12           256. Defendant Nehra, in order to serve his own pecuniary self-interests, willfully  
13 aided, abetted, counseled, induced, and/or procured TelexFree's violations of law regarding the  
14 proper segregation and maintenance of customer funds, and acted in concert and combination  
15 with Defendant TelexFree in such violations.

16           257. Defendant Nehra gave substantial assistance to TelexFree in accomplishing a  
17 tortious result, and Nehra's own conduct, separately considered, constitutes a breach of duty to  
18 Investors because, *inter alia*, he:

- 19           a. Knowingly misrepresented the legality and sustainability of TelexFree's  
20 operations to the detriment of Investors, and received fees from TelexFree for  
21 doing so;
- 22           b. Knowingly obscured and obfuscated the illegal nature of TelexFree's scheme  
23 by the manipulative use of language, including, e.g., advising TelexFree that  
24 the use of the term "investment" must be avoided;
- 25           c. Breached his duty of professional care to investors, by failing to exercise  
26 proper due diligence in investigating the legality of TelexFree's operations;
- 27           d. Advised and encouraged Investors to evade United States securities laws to  
28 the benefit of TelexFree and detriment of the Investors and the public; and

1 e. Engaged in a civil conspiracy to defraud TelexFree’s investors by means of a  
2 Pyramid Ponzi Scheme, and, in fact, took a leading role in the scheme.<sup>21</sup>

3 258. Attorney Waak, as general partner and Principal Attorney of the Law Offices of  
4 Nehra and Waak, was aware of, oversaw, and, upon information and belief, participated in  
5 Attorney Nehra’s tortious conduct with respect to the TelexFree Pyramid Ponzi Scheme.

6 259. Attorney Waak, as general partner and Principal Attorney of the Law Offices of  
7 Nehra and Waak, was aware of, oversaw, and, upon information and belief, participated in  
8 TelexFree Pyramid Ponzi Scheme.

9 **I. TELEXFREE’S CERTIFIED PUBLIC ACCOUNTANT AIDED, ABBETTED**  
10 **AND PLAYED AN INTERGRAL PART IN TELEXFREE’S UNLAWFUL,**  
11 **UNFAIR AND DECEPTIVE PYRAMID PONZI SCHEME**

12 260. As the Chief Financial Officer of TelexFree, Inc. and TelexFree, LLC, Defendant  
13 Craft, also known as Joe H. Craft, has been a certified public accountant and served as the Chief  
14 Financial Officer (“CFO”) of Telex Free, Inc. and TelexFree, LLC.

15 261. Defendant Craft is also the sole Member and Manager of Craft Financial, an  
16 Indiana-based limited liability company.

17 262. Defendants Craft and Craft Financial are indistinguishable with regards to their  
18 involvement with the TelexFree Pyramid Ponzi Scheme.

19 263. Defendants Craft and Craft Financial knowingly participated in and perpetuated  
20 TeleFree’s illegal Pyramid Ponzi Scheme.

21 264. In his dual capacity as CFO and certified public accountant of TelexFree,  
22 Defendants Craft and Craft Financial have been responsible for, *inter alia*, preparing or  
23 approving TelexFree’s financial statements, overseeing TelexFree’s accounting methods and  
24 records, and otherwise exercising significant supervision and control over TelexFree.

13 \$478,251.56 in the second; and Net Income is listed as \$1,066,313.39 in the first, versus  
14 \$477,652.23 in the second.

15           270. The existence of duplicative accounting records containing egregious  
16 discrepancies is clear indicia of TelexFree's falsification of accounting records and failure to  
17 adhere to GAAP.

18           271. As CFO and certified public accountant for TelexFree, Inc. and TelexFree, LLC,  
19 as well as a certified public accountant, Defendants Craft and Craft Financial, knowingly  
20 perpetrated the TelexFree fraud by, *inter alia*:

- 21           a. Overseeing TelexFree's creation of falsified accounting records;
- 22           b. Failing to ensure that GAAP accounting methods were adopted and adhered  
23 to;
- 24           c. Fraudulently certifying TelexFree's business operations and accounting  
25 practices as good and lawful, despite actual knowledge of their unlawful and  
26 illegitimate nature; and
- 27           d. Conspiring with TelexFree's Officers to structure and perpetuate an illegal  
28 pyramid Ponzi scheme designed to defraud Investors and enrich themselves.

1 272. Defendants Craft and Craft Financial disseminated, and otherwise allowed to be  
2 disseminated, false and inaccurate financial information among Investors, knowing that such  
3 information was false and designed to continue and perpetuate the illegal Pyramid Ponzi Scheme.

4 273. In particular, Defendants Craft and Craft Financial authorized TelexFree to  
5 provide Investors with inaccurate and fraudulent 1099 (Miscellaneous Income) forms, in many  
6 cases long after the January 31, 2014 required deadline, and in an effort to misrepresent  
7 payments made to Investors and conceal assets.

8 274. The fact that these inaccurate 1099's are expected to be filed with the Internal  
9 Revenue Service and State Revenue Offices will impose further an undue and massive hardship  
10 upon investors.

11 275. Defendants also prepared false financial documents for affiliated TelexFree  
12 entities and prepared false tax returns for the affiliated TelexFree entities.

13 **J. THE BANKING INSTITUTION AND FINANCIAL SERVICES PROVIDER**  
14 **DEFENDANTS KNOWINGLY AIDED AND ABETTED TELEXFREE'S**  
15 **SCHEME AND RECEIVED FRAUDULENT TRANSFERS OF FUNDS**

16 276. During the course of the TelexFree Pyramid Ponzi Scheme, Defendants TD Bank,  
17 Citizens Financial, Citizens Bank, Fidelity Bank, Middlesex Savings, GPG, IPS, and ProPay and  
18 the Does provided crucial financial services to TelexFree, which enabled TelexFree to carry on  
19 its Pyramid Ponzi scheme.

20 277. TelexFree's financial services providers, including the aforesaid banking  
21 institutions and payment processing services providers, knowingly aided and abetted TelexFree's  
22 Pyramid Ponzi Scheme by, *inter alia*:

- 23 a. Receiving transfers of funds from, and on behalf of, TelexFree in the course  
24 of TelexFree's fraudulent business, despite knowledge of the fraudulent nature  
25 of TelexFree's business enterprise;
- 26 b. Receiving transfers of funds from TelexFree, its affiliated entities, and its  
27 executive officers, which transfers deepened TelexFree's insolvency, despite  
28 having knowledge of TelexFree's actual or imminent insolvency at the time of

such transfers;

- c. Processing payments to, and on behalf of, TelexFree, including its affiliated entities and Management, in the course of TelexFree’s fraudulent business, despite knowledge of the fraudulent nature of TelexFree’s business enterprise; and
- d. Otherwise enabling the TelexFree Pyramid Ponzi Scheme to expand and continue by providing necessary financial services to TelexFree, despite actual knowledge of fraud on the part of TelexFree.

278. Defendants, TD Bank, Citizens Financial, Citizens Bank, Fidelity Bank, the “Doe” banks and Middlesex Savings (hereinafter sometimes collectively referred to as “Banking Institution Defendants”) possessed actual knowledge of the fraudulent nature of TelexFree’s business operation, since at least June 2013.

279. Despite knowledge of the fraudulent nature of TelexFree’s business operations, the Banking Institution Defendants continued to provide TelexFree with banking services.

280. In particular, upon information and belief, the Banking Institution Defendants received funds from Investors, which funds were then held for the benefit of TelexFree, its affiliated entities, and its Management.

281. Furthermore, the Banking Institution Defendants also received large transfers of funds from TelexFree, its affiliated entities, and its Management, during which time TelexFree was insolvent, despite knowledge of the fraudulent nature of TelexFree’s business operations, thereby deepening TelexFree’s insolvency and assisting TelexFree and its Management in concealing assets.

282. Defendants GPG, IPS, the “Doe” payment processors and ProPay (hereinafter sometimes collectively referred to as “Payment Processing Services Companies” or “PPSC Defendants”) possessed actual knowledge of the fraudulent nature of TelexFree’s business operations since at least June 2013.

283. Despite knowledge of the fraudulent nature of TelexFree’s business operations, the PPSC Defendants continued to provide TelexFree with payment processing services.

1 284. More particularly, the PPSC Defendants processed payments by Investors to  
2 TelexFree in the course of TelexFree's fraudulent business operations, which funds were then  
3 held for the benefit of TelexFree, its affiliated entities, and its Management.

4 285. Upon information and belief, the PPSC Defendants also processed large transfers  
5 of funds from TelexFree, its affiliated entities, and its Management, to Banking Institution  
6 Defendants and other receivers, during which time TelexFree was insolvent, despite knowledge  
7 of the fraudulent nature of TelexFree's business operations, thereby deepening TelexFree's  
8 insolvency and assisting TelexFree and its Management in concealing assets.

9 286. The PPSC Defendants received payment of substantial fees in return for providing  
10 these services.

11 287. More particularly, IPS provided TelexFree with a service titled "e-Wallet," which  
12 was used by TelexFree to process electronic transfers of funds by Investors to TelexFree.

13 288. According to a TelexFree balance sheet, dated December 31, 2013, posted by the  
14 Washington State Utilities and Transportation Commission, as of December 31, 2013, TelexFree  
15 claimed \$31,640,192.30 in assets then held by IPS (under the brand name "e-Wallet") on behalf  
16 of TelexFree.

17 289. Defendant GPG also processed electronic transfers of funds by Investors to  
18 TelexFree.

19 290. Defendant ProPay, which also does business as Propay.com, also processed such  
20 electronic transfers of funds on behalf of TelexFree.

21 291. Furthermore, upon information and belief, ProPay processed transfers of funds by  
22 and on behalf of TelexFree, its affiliated entities, and its Management, during which time  
23 TelexFree was insolvent, despite knowledge of the fraudulent nature of TelexFree's business  
24 operations, thereby deepening TelexFree's insolvency and assisting TelexFree and its  
25 Management in concealing assets.

26 ...

28 ...

1 **K. TELEXFREE**

2 292. TelexFree, LLC or TelexFree, Inc. (hereafter referred to as “TelexFree”) is a  
3 marketer of telecommunications and advertising primarily targeting the hard-working Brazilian -  
4 American and Dominican- American communities.

5 293. Other minority groups have also been victimized.

6 294. TelexFree is currently under investigation for offering fraudulent and unregistered  
7 securities by running a multi-level marketing scheme.

8 295. This scheme borrows elements from the once common phone card frauds of the  
9 mid-2000’s, while supercharging its reach through an elaborate internet-marketing machine.

10 296. Using various interrelated business operations, fraudulent practices, schemes,  
11 bank accounts and entities, TelexFree claims it has raised nearly \$1,000,000,000.00 worldwide.<sup>22</sup>

12 297. TelexFree has not received \$1,000,000,000.00 worldwide.

13 298. As with all Ponzi or pyramid Schemes, TelexFree operations are untenable  
14 without a continuous influx of new capital.

15 299. Indeed, the financial basis of the TelexFree scheme centers on the recruitment of  
16 additional participants and placing online advertisements – not the sales of 99TelexFree Voice  
17 over Internet Protocol computer programs (hereinafter “VoIP Program(s)”).

18 300. Class Members were fraudulently induced to invest in at least two other “scam”  
19 business opportunities involving the offer or sale of unregistered securities in Massachusetts,  
20 namely, 1) TelexFree’s passive income scheme, and 2) an offer to invest in TelexFree’s hotel  
21 program.

22 301. Despite the fact that upon the advise of their legal counsels, TelexFree referred to  
23 the members of the putative class as Associates and Promoters, Plaintiffs Martins and Valentim  
24 and all members of the putative class member are considered under federal and state securities  
25 law as “Investors”.

26 . . .

1 **L. TELEXFREE'S PONZI SCHEME IS A PYRAMID**

2 302. In January 2013, the Brazilian Bureau of Consumer Protection (known as  
3 Procon), began a investigation into TelexFree. In its January 11, 2013 press release, Procon  
4 indicated that it had "*detected evidence of crimes*":

5 The investigation initiated by civil prosecution of Consumer  
6 Protection (no. 01/2013) shows several controversial issues and  
7 possible crimes that put consumers at risk in time to accept that  
8 kind of deal.

9 Among the possibilities, there is a breach in the Federal Law No.  
10 1.521/51, art. 2, according to which it is a crime:

11 "Obtaining or attempting to obtain illicit gains at the expense of  
12 the people or of undetermined number of people through  
13 speculation or processes fraudulent ('snowball', 'chains',  
14 'pichardismo' and any other equivalent)" including Ponzi  
15 pyramid".

16 There is also the possible violation of the Code of Consumer  
17 Protection (CDC), with false advertising, failure of product  
18 information and company, abuse of weakness or ignorance of  
19 consumers and conditions unreasonable disadvantage, among  
20 others.<sup>23</sup>

21 283. Procon subsequently initiated an official complaint and notified the "State  
22 Prosecutors Office, the Minister of Finance and the Federal Police."<sup>24</sup> The Ministry of Finance,  
23 after its investigation, declared that:

24 The Telexfree business of selling packages of internet telephony  
25 (VoIP, its acronym in English), is not sustainable and suggests a  
26 Ponzi scheme, which is a crime against the popular economy.

27 That is the conclusion of the Secretariat for Economic Monitoring  
28 of the Ministry of Finance (Seae / MF) in a statement on Thursday  
(14).<sup>25</sup>

29 284. As the matter processed through the Brazilian Court System, the Ministry of  
30 Finance was ordered to refrain from issuing further statements about the matter. In a blatantly

1 misleading and deceptive act, TelexFree circulated through its affiliates the following  
2 misrepresentation of the order:

3  
4 It's official! The investigation on TelexFree has been absolved of  
what Behind MLM has researched and posted.<sup>26</sup>

5 285. On June 19, 2013, the Brazilian Court in Acre issued an injunction putting "a stop  
6 to TelexFree's business operations, including the registration of new affiliate investors,  
7 acceptance of new investments and paying any returns owed on existing affiliate investments."<sup>27</sup>

8 286. At all times material herein, the other Defendants knew that TelexFree was and  
9 illegal Pyramid Ponzi Scheme which involved the illegal sale of securities, but continued to aid,  
10 abet and further such illegal activities. Despite the foregoing knowledge, TelexFree and the  
11 other Defendants continued to participate in the attraction and processing of new investors,  
12 continued to allow payments to process through TelexFree's accounts, allowed TelexFree to  
13 continue to illegally sell securities and further its illegal Pyramid Ponzi Scheme, and otherwise  
14 continued to further TelexFree's illegal activities.

15 287. On March 9, 2014, TelexFree changed its compensation plan, thereby requiring  
16 Promoters to sell its VoIP product in order to qualify for the payments that TelexFree had  
17 previously promised to pay them. The rule change generated a storm of protests from Promoters  
18 who were unable to recover their money.

19 288. On April 1, 2014, dozens of Promoters descended upon TelexFree's  
20 Marlborough, Massachusetts office to protest this change and attempt to regain access to their  
21 money. Local media covering interviewed one Promoter who admitted that the VoIP service is  
22 "almost impossible to sell".<sup>28</sup> On April 14, 2014, Defendants TelexFree, Inc., TelexFree, LLC  
23 and TelexFree Financial abruptly sought bankruptcy protection in Nevada under Chapter 11,  
24

1 admitting that they cannot meet their obligations from VoIP revenues and seeking authority to  
2 reject all its current obligations to promoters.

3 289. At all relevant times herein, Defendants engaged in: (a) fraudulent or deceptive  
4 conduct in connection with the purchase or sale of securities, in violation of Section 10 (b) of the  
5 Exchange Act of 1934 ("Exchange Act") and Rule 10b-5 thereunder; (b) fraud in the offer or sale  
6 of securities, in violation of Section 17(a) of the Securities Act of 1933 ("Securities Act"); and  
7 (c) the offer or sale of unregistered securities, in violation of Section 5 of the Securities Act.

8 290. In addition, TelexFree and the other Defendants unlawfully, willfully and  
9 knowingly used means and instrumentalities, directly and indirectly, in connection with the  
10 purchase and sale of unregistered securities; and used and employed manipulative and deceptive  
11 devices and contrivances in violation of, *inter alia*, the Massachusetts Uniform Securities Act,  
12 M.G.L. c. 110A, Section 410b.

13 291. Plaintiffs make the following allegations upon information and belief and the  
14 investigation of their counsel, except as to their own actions and the facts that are a matter of  
15 public record:

16 292. TelexFree's business purportedly centers on the sale of its VoIP Program, 99  
17 TelexFree, despite the fact that TelexFree's president testified to having limited knowledge of  
18 VoIP and never having been in the telecom business.

19 293. A VoIP computer program, such as 99TelexFree, allows an individual to place  
20 phone calls over the Internet.

21 294. In effect, an individual can use VoIP as a substitute for traditional landline phone  
22 services.

23 295. Using technology borrowed from Disk A Vontade, a nearly identical venture with  
24 common management, TelexFree rebranded the VoIP Program, offering it for a flat monthly fee  
25 of \$49.90.

26 296. Unlike Disk A Vontade operations, however, TelexFree coupled the VoIP  
27 Program with a wildly lucrative and fraudulent scheme (hereinafter the "Passive Income  
28 Scheme").

1 297. The core of the Passive Income Scheme centers on the investment of either  
2 \$289.00 or \$1,375.00.

3 298. A participant who invests \$289.00 receives one advertisement kit and ten VoIP  
4 Programs.

5 299. A participant who invests \$1,375.00 receives five advertisement kits and fifty  
6 VoIP Programs.

7 300. The TelexFree advertisement kit enables participants to generate a return by  
8 posting pre-written advertisements, to pre-determined websites, through an automated TelexFree  
9 system.

10 301. A participant's daily use of the advertisement kits generates investment returns  
11 without the need for any VoIP Program sales.

12 302. As testified to, posting advertisements is an effortless process that takes only a  
13 few minutes per advertisement.

14 303. Indeed, many participants pay third parties to post advertisements – completely  
15 outsourcing any required work at a minimal cost.

16 304. By merely posting one advertisement each day of the week, the TelexFree  
17 participant receives an additional VoIP Program.

18 305. The participant can sell the additional VoIP Program to TelexFree for \$20.00.

19 306. Thus, over the course of the year, a participant who initially invests \$289.00 and  
20 does nothing more than place one advertisement per day can receive profit of at least \$681.00 – a  
21 return in excess of 200%.

22 307. Alternatively, a participant who initially invests \$1,375.00 and does nothing more  
23 than place five advertisements per day can receive profit of at least \$3,675.00 – a return in excess  
24 of 250%.

25 308. This feature alone has attracted thousands of individuals to invest in TelexFree.

26 309. The Passive Income Scheme generates further returns for participants through  
27 various bonus structures and recruitment commissions.

28 310. TelexFree tailors each of the additional income streams to incentivize recruitment.

1 311. By merely recruiting one individual into the TelexFree scheme, a participant can  
2 receive as much as \$100.00.

3 312. By recruiting multiple individuals, TelexFree participants become eligible for  
4 revenue sharing bonuses of up to 3% of the TelexFree's VoIP Program sales.

5 313. Hidden among TelexFree's bonus structure and recruitment commissions is the  
6 fact that TelexFree participants may self-qualify.

7 314. Indeed, as testified by participants, a participant may invest in more than one  
8 advertisement kit and personally purchase the VoIP Program to earn bonuses.

9 315. Thus, a participant may purchase a VoIP Program, never use the program, and  
10 still qualify for additional income.

11 316. Without ever selling any VoIP Program, the participant receives a return far in  
12 excess of the 200-250% guaranteed return.

13 317. To drum up interest in recruiting, TelexFree held extravaganzas complete with a  
14 rock concert atmosphere and wild cheering, including the "wave."

15 318. Until recently, the TelexFree website and TelexFree presentations included  
16 pictures of cash and luxury property.

17 319. In one such presentation, TelexFree touted the Passive Income Scheme as "the  
18 opportunity of a lifetime."

19 320. Through such fantasies, reserved only for those at the top of the Passive Income  
20 Scheme, TelexFree induced investments drawn from participants' earnest earnings and savings.

21 321. Troublingly, TelexFree allowed certain participants to join the scheme despite  
22 prior run-ins with the law.

23 322. TelexFree prominently highlighted one such participant, Defendant Rodrigues, as  
24 the top promoter in the world on the TelexFree website.

25 323. Rodrigues, a self-proclaimed millionaire, had previously operated a similar multi-  
26 level marketing phone card fraud shuttered by the SEC in 2006.

27 324. TelexFree's revenue from VoIP Programs sales alone is inadequate to satisfy  
28 participant returns.

1 325. In 2012 and 2013, TelexFree identified 4,845,576 VoIP Program transactions  
2 totaling \$238,395,353.80.

3 326. Net revenue received by TelexFree from VoIP Program sales was significantly  
4 less due to substantial commission payments.

5 327. Importantly, TelexFree founder Wanzeler could not identify the number of  
6 individuals purchasing only a VoIP Program without also becoming a participant.

7 328. Wanzeler provided wildly varied estimates when challenged to identify the  
8 number of VoIP Programs sold to non-participants.

9 329. Over the same period, TelexFree had 783,771 investments of either \$289.00 or  
10 \$1,375.00 totaling \$880,189,455.32.

11 330. Assuming that each participant invested only \$289.00 and did no more than post  
12 one advertisement per day, TelexFree owed participants a total of \$799,446,420.00.

13 331. Alternatively, if each participant invested only \$1,375.00 and did no more than  
14 post five advertisements per day, TelexFree owed \$3,997,232,100.00 to its participants.

15 332. According to data provided by TelexFree, \$1,375.00 investments accounted for  
16 88% of transactions through Massachusetts-based participants.

17 333. Even assuming that only 50% of all participant investments were for \$1,375.00,  
18 TelexFree would still owe \$2,398,897,200.00 – a number that far exceeds TelexFree’s reported  
19 total revenues over the same period.

20 334. This figure of almost \$2.4 billion does not even include further bonuses,  
21 recruitment commissions, and revenue sharing.

22 335. The inclusion of these additional payments would create an even greater disparity  
23 between the VoIP Program revenue and guaranteed money paid out of the Passive Income  
24 Scheme to participants.

25 336. In addition to the Passive Income Scheme, TelexFree, through a Brazilian  
26 affiliate, offered an investment in a Best Western Hotel.

27 337. As described by TelexFree’s president, the Best Western Hotel opportunity was  
28 an important marketing tool to bolster TelexFree credibility worldwide.

1 338. TelexFree management facilitated the offer of the Best Western Hotel opportunity  
2 through the inclusion of the Best Western Hotel opportunity on the front page of the TelexFree  
3 website accessible in the Commonwealth.

4 339. Through a prominently placed website banner and video, TelexFree presented an  
5 investment opportunity with a guaranteed yearly return of over 8%.

6 340. The Best Western Hotel opportunity video remained on the United States-based  
7 TelexFree website for months despite the fact that the president of TelexFree was aware of the  
8 video and requested TelexFree's website staff to remove the video.

9 341. In fact, the difference between U.S. TelexFree operations and Brazilian operations  
10 is a distinction without a difference.

11 342. As described by TelexFree management, the ownership interests in TelexFree,  
12 Inc. (Massachusetts-based), TelexFree LLC (Nevada-based) and Ympactus (Brazilian-based),  
13 overlap.

14 343. Both Defendants Merriland Wanzeler, self-proclaimed founders of TelexFree,  
15 hold 50% ownership interest in the United States entities and 20% and 40% interests,  
16 respectively, in the Brazilian entity.

17 344. Defendant Costa, head of Brazilian operations and longtime friend of Wanzeler,  
18 was an owner of TelexFree, LLC.

19 345. In late 2013, Costa withdrew his ownership for what Merrill characterized as  
20 "legal reasons."

21 346. Furthermore, TelexFree entities use the same website and back office support,  
22 merely providing identical information in multiple languages.

23 347. Perhaps most telling, both Merrill and Wanzeler testified to transferring at least  
24 \$3,000,000.00 to Costa long after Brazilian authorities shut down Ympactus operations.

25 348. Over two years of operations, TelexFree has employed multiple financial  
26 accounts, including domestic and international bank accounts and various online payment  
27 processors, to facilitate the fraudulent offer or sale of securities in the Commonwealth of  
28 Massachusetts.

1 349. Almost all financial institutions have terminated their relationship with TelexFree  
2 after only a few months of business.

3 350. Recently, frantic emails between TelexFree management and financial institutions  
4 paint an entirely bleak picture of continuing TelexFree financial operations.

5 351. TelexFree operations have become a risk that financial institutions are no longer  
6 willing to bear.

7 352. As described by one financial institution, “[n]o US Bank or Processor . . . will  
8 accept your [TelexFree] business given that you are on month five of the Visa Chargeback  
9 monitoring program. You are one of only three merchants in the USA on month five so you are  
10 a real hot-potato as they say.”

11 353. Recently, on March 9, 2014, TelexFree management made several changes to its  
12 once wildly popular Passive Income Scheme.

13 354. A central component of the new changes affect the ease of participant  
14 withdrawals.

15 355. TelexFree participants are no longer able to withdraw money, even money already  
16 “earned,” without making a specified number of retail sales and recruiting a number of new  
17 investors.

18 356. Certain TelexFree participants have frantically contacted the Division suspecting  
19 that these changes are the harbinger of TelexFree’s collapse.

20 357. Not only is it now more difficult to withdraw money from TelexFree, TelexFree  
21 has also switched its compensation plan from one that pays participants in dollars to one that  
22 operates on TelexFree “credits.”

23 358. These credits appear to be nothing more than IOUs. To this end, on April 14,  
24 2014, TelexFree filed for Chapter 11 bankruptcy protection in Nevada.

25 **M. DISK A VONTAD**

26 359. Disk a Vontade is operated out of a Massachusetts post office box. TelexFree and  
27 Disk a Vontade share key management and prior to their activities as described herein, they  
28 shared Brazil as a target market.



1 360. Disk a Vontade's domain ("discavontade.com") is registered to Defendant Carlos  
2 Wanzeler.

3 361. Defendant James Merrill has attended Disk a Vontade events including those held  
4 in Brazil.

5 **N. TELEXFREE ELECTRIC**

6 362. Defendants Merrill and Wanzeler are the general partners of TelexElectric.

7 363. TelexFree Electric received a fraudulent \$2,022,329.00 "loan" from TelexFree  
8 following the closure of TelexFree Brazil by the Brazilian Courts.

9 **O. TELEXFREE MOBILE**

10 364. TelexFree Mobile received a fraudulent \$500,870 "loan" from TelexFree.

11 **P. DOE INSIDER PROMOTERS**

12 365. Although they remain unknown to the Putative Class Representatives and will  
13 remain unknown until discovery has been exchanged, certain promoters were provided with  
14 inside information by Defendants and in fact acted as agents servants of the Defendants.

15 366. The Putative Class Representatives seek to obtain damages, restitution and  
16 injunctive relief for the Class, as defined, below, from Defendants.

17 **CLASS ACTION ALLEGATIONS**

18 367. Pursuant to Rule 23 of the Federal Rules of Civil Procedure, Plaintiffs bring this  
19 action on their own behalf, and on behalf of all other persons similarly situated ("the Class").  
20 The Class that Plaintiffs seek to represent is:

21 All persons who tendered funds to TelexFree between 1/1/2012  
22 and April 15, 2014 and who did not recoup the amount of money  
23 they originally invested. Excluded from the Class are the  
24 Defendants and their officers, directors, and employees of  
25 Defendant; any entity in which Defendant have a controlling  
interest; the co conspirators, so called insider promoters, legal  
representatives, attorneys, heirs, and assigns of the Defendants.

26 368. Plaintiffs meet the requirements of Federal Rules of Civil Procedures 23(a)  
27 because the members of the Class are so numerous that the joinder of all members is impractical.  
28

1 While the exact number of Class members is unknown to Plaintiffs at this time, based on  
2 information and belief, it is in the hundreds of thousands.

3 369. Plaintiffs meet the requirements of Federal Rules of Civil Procedures 23(a)  
4 because there is a well-defined community of interest among the members of the Class, common  
5 questions of law and fact predominate, Plaintiffs' claims are typical of the members of the Class,  
6 and Plaintiffs can fairly and adequately represent the interests of the Class.

7 370. This action satisfies the requirements of Federal Rule of Civil Procedure 23(b)(3)  
8 because it involves questions of law and fact common to the member of the Class that  
9 predominate or any questions affecting only individual members, including, but not limited to:

- 10 a. Whether the contract under which TelexFree claims to invoke the  
11 application of Nevada law is illegal and unenforceable as a matter of law.
- 12 b. Whether the contract under which TelexFree claims to invoke the  
13 application of Nevada law is otherwise void and unenforceable as a matter  
14 of law.
- 15 c. Whether TelexFree ran a Pyramid Ponzi Scheme;
- 16 d. Whether TelexFree ran a lawful Multi-Level Marketing program;
- 17 e. Whether TelexFree offered and sold securities in the form of unregistered  
18 investment contracts constituting securities.
- 19 f. Whether the other Defendants aided and abetted TelexFree in the sale of  
20 unregistered securities in violation of the law;
- 21 g. Whether Defendant Officers, Doe Inside Promoters, Doe Paralegal, Banks,  
22 Payment Processing Services Companies, Retained Licensed Professionals  
23 knew that TelexFree was an illegal pyramid-type Ponzi scheme which  
24 involved the illegal sale of securities, continued to aid, abet and further  
25 such illegal activities or are otherwise liable for the economic loss suffered  
26 by the Putative Class.
- 27 h. Whether TelexFree's financial services providers, including the aforesaid  
28 banking institutions and payment processing services providers, knowingly

- 1 aided and abetted TelexFree's Pyramid Ponzi Scheme
- 2 i. Whether Massachusetts Blue Sky Laws will apply to the claims of the
- 3 Putative Class;
- 4 j. Whether TelexFree and the other Defendants used and employed
- 5 manipulative and deceptive devices and contrivances in violation of MGL
- 6 110A, Sec. 410; used means and instrumentalities, directly and indirectly,
- 7 in connection with the purchase and sale of unregistered securities; and
- 8 used and employed manipulative and deceptive devices and contrivances
- 9 in violation of, *inter alia*, the Massachusetts Uniform Securities Act, MGL
- 10 c. 110A, Section 410b, MGL 110A, Sec. 410(b) and MGL 93A.
- 11 k. Whether TelexFree and the other Defendants also violated Title 17, Code
- 12 of Federal Regulations, Section 240.10b-5 by (a) employing devices,
- 13 schemes, and artifices to defraud; (b) making untrue statements of material
- 14 facts and omitting to state material facts necessary in order to make the
- 15 statements made, in the light of the circumstances under which they were
- 16 made, not misleading, and (c) engaging in acts, practices, and courses of
- 17 business which operated and would operate as a fraud and deceit upon
- 18 persons.
- 19 l. Whether Defendant's violated Section 1965 of the Racketeer Influenced
- 20 and Corrupt Organizations Act [18 U.S.C. § 1965];
- 21 m. Whether TelexFree mailed fraudulent and inaccurate 1099 (Miscellaneous
- 22 Income) forms to investors;
- 23 n. Whether the 1099 (Miscellaneous Income) forms should be declared void
- 24 as a matter of law or otherwise because they were provided long after the
- 25 mandated January 31, 2014 deadline, and some after the April 15, 2014
- 26 filing deadline.
- 27 o. Whether Plaintiff and the Class are entitled to damages, civil penalties,
- 28 punitive damages, and/or injunctive relief.

1 371. Plaintiffs' claims are typical of those of other Class members because Plaintiffs'  
2 information, like that of every other class member, was misused and/or disclosed by Target.

3 372. Plaintiffs will fairly and accurately represent the interests of the Class.

4 373. The prosecution of separate actions by individual members of the Class would  
5 create a risk of inconsistent or varying adjudications with respect to individual members of the  
6 Class, which would establish incompatible standards of conduct for Target and would lead to  
7 repetitive adjudication of common questions of law and fact. Accordingly, class treatment is  
8 superior to any other method for adjudicating the controversy. Plaintiffs know of no difficulty  
9 that will be encountered in the management of this litigation that would preclude its maintenance  
10 as a class action under Rule 23(b)(3).

11 374. Damages for any individual class member are likely insufficient to justify the cost  
12 of individual litigation, so that in the absence of class treatment, Target's violations of law  
13 inflicting substantial damages in the aggregate would go un-remedied without certification of the  
14 Class.

15 375. Target has acted or refused to act on grounds that apply generally to the class, as  
16 alleged above, and certification is proper under Rule 23(b)(2).

17 **FIRST CLAIM FOR RELIEF**

18 **(FOR VIOLATIONS OF SECTION 10(B) OF THE SECURITIES AND EXCHANGE ACT**  
19 **OF 1934 AND SECURITIES AND EXCHANGE COMMISSION RULE 10B-5 -AGAINST**  
20 **DEFENDANTS TELEXFREE, MERRILL, WANZELER, LABRIOLA, CRAFT, COSTA,**  
**AND OTHERS)**

21 376. Plaintiffs incorporate by reference the allegations contained in Paragraphs 1 -375  
22 as if fully restated herein.

23 377. During the class period, Defendants, directly and indirectly, by the use of means  
24 or instrumentalities of interstate commerce and/or of the mails, engaged and participated in a  
25 scheme and a continuous course of conduct to make materially false and misleading statements  
26 about the TelexFree investment dealings, financial condition and operations and to conceal  
27 adverse material information about these investments.

28 . . .

1 378. Defendants employed devices, schemes, and artifices to defraud, while in  
2 possession of material adverse non-public information and engaged in acts, practices, and  
3 courses of conduct, as alleged herein, including the following: (1) making or participating in the  
4 making of untrue statements of material facts; (2) omitting to state the material facts necessary to  
5 make the statements about the investments not misleading; and (3) engaging in transactions,  
6 practices, and a course of business which operated as a fraud and deceit upon investors during  
7 the Class Period.

8 379. Each of the said Defendants offered and sold securities by means of fraudulent  
9 misrepresentations and intentional omissions of material facts concerning the securities.

10 380. Defendants had actual knowledge of the misrepresentations and omissions of  
11 material facts set forth herein, or acted with reckless disregard for the truth in that they failed to  
12 ascertain and to disclose such facts, even though such facts were available to them. Such  
13 misrepresentations and/or omissions were done knowingly or recklessly for the purpose and  
14 effect of concealing the true information about the investments, including their financial  
15 condition and operations.

16 381. Defendants received information reflecting the true facts regarding the investment  
17 and TelexFree's business practices, exercised control over and/or receipt of the materially  
18 misleading misstatements and/or their association with the investment and made them privy to  
19 confidential proprietary information concerning these investments. Because of their control  
20 and/or association with the investment, Defendants were active and culpable participants in the  
21 fraudulent scheme.

22 382. Defendants knew and/or recklessly disregarded the falsity and misleading nature  
23 of the information that they caused to be disseminated to Investors.

24 383. The ongoing fraudulent scheme described herein could not have been perpetrated  
25 over a substantial period of time, without the knowledge and complicity of Defendants.

26 384. As a result of the dissemination of materially false and misleading information  
27 and the failure to disclose material facts, as set forth above, Investors paid artificially inflated  
28 prices for worthless membership interests in the investment during the Class Period.

1 385. In ignorance of the materially false and misleading nature of the reports and  
2 statements described above, Plaintiffs and the other Class members relied, to their detriment, on  
3 Defendants for complete and accurate information about these investments.

4 386. By virtue of the foregoing, Defendants have violated Section 10(b) of the  
5 Exchange Act, and Rule 10 b-5 promulgated thereunder, and Plaintiffs and the Class have been  
6 damaged thereby, in an amount to be proven at trial.

7 **SECOND CLAIM FOR RELIEF**

8 **(FOR VIOLATIONS OF SECTION 20(A) OF THE SECURITIES AND EXCHANGE**  
9 **ACT 1934 AND SECTION 15 OF THE SECURITIES ACT OF 1933 AGAINST**  
10 **DEFENDANTS MERILL, WANZELER, LABRIOLA, CRAFT, CRAFT FINANCIAL,**  
11 **COSTA, WAAK, NEHRA, LAW OFFICES OF NEHRA AND WAAK, AND GERALD P.**  
12 **NEHRA, ATTORNEY AT LAW, PLLC)**

13 387. Plaintiffs incorporate by reference the allegations contained in Paragraphs 1 - 386  
14 as if as fully restated herein.

15 388. At the time of the wrongs alleged herein, Defendants Merrill, Wanzeler, Labriola,  
16 Craft, Craft Financial, Costa, Waak, Nehra, Law Offices of Nehra and Waak, and Gerald P.  
17 Nehra, Attorney at Law, PLLC, were each a controlling person of TelexFree within the meaning  
18 of Section 20(a) of the Exchange Act.

19 389. By reason of their respective positions of authority, Merrill, Wanzeler, Labriola,  
20 Craft, Craft Financial, Costa, Waak, Nehra, Law Offices of Nehra and Waak, and Gerald P.  
21 Nehra, Attorney at Law, PLLC had the power and authority to influence and control, and did  
22 influence and control, the decision-making and activities of TelexFree and the affiliated  
23 TelexFree Entities and caused them to engage in the wrongful conduct described herein.  
24 Defendants, Merrill, Wanzeler, Labriola, Craft, Craft Financial, Costa, Nehra, Law Offices of  
25 Nehra and Waak, and Gerald P. Nehra, Attorney at Law, PLLC, exercised control to cause the  
26 dissemination of false and misleading statements and omissions of material facts.

27 390. Defendants Merrill, Wanzeler, Labriola, Craft, Craft Financial, Costa, Waak,  
28 Nehra, Law Offices of Nehra and Waak, and Gerald P. Nehra, Attorney at Law, PLLC also

1 materially aided in the sale of TelexFree AdCentral packages, which constitute securities, by  
2 actively promoting such

3 391. By virtue of their positions as controlling persons, and as a result of the  
4 aforementioned conduct, Defendants are liable under Section 20(a) of the Exchange Act.

5 **THIRD CLAIM FOR RELIEF**

6 **(FOR VIOLATIONS OF SECTIONS 5 AND 12(A)(L) OF**  
7 **THE SECURITIES ACT OF 1933 AGAINST DEFENDANTS TELEXFREE, MERRILL,**  
8 **WANZELER, LABRIOLA, CRAFT, COSTA, AND OTHERS)**

9 392. Plaintiffs incorporate by reference the allegations contained in Paragraphs 1 – 391  
10 as if fully restated.

11 393. The Securities Act prohibits sale or delivery after sale of an unregistered security.

12 394. Defendants TelexFree, Merrill, Wanzeler, Labriola, Craft, Costa, the Insider  
13 Promoter Does and others failed to file a true Registration Statement for TelexFree under the  
14 1933 Act.

15 395. A Registration Statement must include the following: (1) the entity's properties  
16 and business, (2) a full description of the offered security, (3) information about the management  
17 of the entity, and (4) a financial statement certified by an independent auditor. None of these  
18 were provided.

19 396. By omitting this information, Defendants filed a false Form D.

20 397. Defendants TelexFree, Merrill, Wanzeler, Labriola, Craft, Costa, , the Insider  
21 Promoter Does and others also did not apply for or receive an exemption under Regulation D.

22 398. Defendants TelexFree, Merrill, Wanzeler, Labriola, Craft, Costa, the Insider  
23 Promoter Does and others failed to provide to Plaintiffs access to the information that they were  
24 required to provide, including audited financial statements.

25 399. Plaintiffs purchased these securities without knowledge of the failure of  
26 Defendants TelexFree, Merrill, Wanzeler, Labriola, Craft, Costa, the Insider Promoter Does and  
27 others to file the required Registration Statement or receive an exemption therefrom.  
28

1 400. Plaintiffs would not have purchased the securities if Defendants TelexFree,  
2 Merrill, Wanzeler, Labriola, Craft, Costa, the Insider Promoter Does and others provided the  
3 information required in a Registration Statement.

4 401. By virtue of the foregoing, Plaintiffs have been damaged and are entitled to  
5 damages, including rescission, and other relief for violations by Defendants TelexFree, Merrill,  
6 Wanzeler, Labriola, Craft, Costa, the Insider Promoter Does and others of Sections 5 and  
7 12(a)(1) of the Securities Act of 1933 alleged herein.

8 **FOURTH CLAIM FOR RELIEF**

9 **(FOR VIOLATIONS OF SECTION 11 OF THE SECURITIES ACT OF 1933 AGAINST**  
10 **DEFENDANTS TELEXFREE, MERILL, WANZELER, LABRIOLA, CRAFT, CRAFT**  
11 **FINANCIAL, COSTA, WAAK, NEHRA, LAW OFFICES OF NEHRA AND WAAK,**  
12 **AND GERALD P. NEHRA, ATTORNEY AT LAW, PLLC)**

13 402. Plaintiffs incorporate by reference the allegations contained in Paragraphs 1 - 401  
14 as if fully restated herein.

15 403. During the class period, Defendants TelexFree, Merill, Wanzeler, Labriola, Craft,  
16 Craft Financial, Costa, Waak, Nehra, Law Offices of Nehra and Waak, and Gerald P. Nehra,  
17 Attorney at Law, PLLC, fraudulently failed to convey facts material to the TelexFree AdCentral  
18 investment packages by failing to produce and file a Registration Statement.

19 404. In particular, the said Defendants intentionally avoided the requirement to  
20 produce a Registration Statement, and intentionally avoided disclosing that the AdCentral  
21 packages were, in fact, investments, and that financial returns on the AdCentral investments were  
22 derived from the proceeds received from the purchase of such investments, and not from the sale  
23 of the VoIP product.

24 405. Said Defendants had actual knowledge of the misrepresentations and omissions of  
25 material facts set forth herein.

26 406. Such misrepresentations and/or omissions were done knowingly for the purpose  
27 and effect of concealing the true information about the investments, including their financial  
28 condition and operations.



1 407. Said Defendants received information reflecting the true facts regarding the  
2 investment and TelexFree's business practices, exercised control over and/or receipt of the  
3 materially misleading misstatements and/or their association with the investment and made them  
4 privy to confidential proprietary information concerning these investments.

5 408. Because of their control and/or association with the investment, Defendants were  
6 active and culpable participants in the fraudulent scheme.

7 409. Said Defendants knew and recklessly disregarded the falsity and misleading  
8 nature of the information that they caused to be disseminated to Investors.

9 410. The ongoing fraudulent scheme described herein could not have been perpetrated  
10 over a substantial period of time without the knowledge and complicity of the Defendants.

11 411. As a result of failure to disclose material facts, as set forth above, including their  
12 failure to file the requisite registration material, Investors paid artificially inflated prices for  
13 worthless membership interests in the investment during the Class Period.

14 412. By virtue of the foregoing, said Defendants have violated Section 11 of the  
15 Securities Act, and Plaintiffs and the Class have been damaged thereby, in an amount to be  
16 proven at trial.

17 **FIFTH CLAIM FOR RELIEF**

18 **(FOR VIOLATIONS OF SECTION 12(A)(2) OF**  
19 **THE SECURITIES ACT OF 1933 AGAINST DEFENDANTS TELEXFREE,**  
20 **MERRILL, WANZELER, LABRIOLA, CRAFT, COSTA, AND OTHERS)**

21 413. Plaintiffs incorporate by reference the allegations contained in Paragraphs 1 - 412  
22 as if fully restated herein.

23 414. Defendants TelexFree, Merrill, Wanzeler, Labriola, Craft, Costa, the Insider  
24 Promoter Does and others participated in the sale of securities to Plaintiffs that were unregistered  
25 and not exempt from registration.

26 415. At the time of their investments, Plaintiffs had no knowledge that the investments  
27 offered by Defendants TelexFree, Merrill, Wanzeler, Labriola, Craft, Costa, the Insider Promoter  
28 Does and others were subject to registration requirements.

1 416. In fact, Defendants TelexFree, Merrill, Wanzeler, Labriola, Craft, Costa, the  
2 Insider Promoter Does and others knew or reasonably should have known that the TelexFree  
3 Agreement Contract and investment scheme was subject to the registration requirement of the  
4 Securities Act.

5 417. Both the Telex Contract and related materials distributed to Plaintiffs and the oral  
6 communications with Plaintiffs contained material omissions and misstatements.

7 418. Plaintiffs had no knowledge of the falsity of these statements or of the material  
8 omissions in the written materials including, but not limited to, Monthly Accounting Statements  
9 prepared by the accounting Defendants and other misrepresentations made by Defendants  
10 TelexFree, Merrill, Wanzeler, Labriola, Craft, Costa, the Insider Promoter Does and others as  
11 described above. Plaintiffs reasonably believed such statements were true.

12 419. Defendants TelexFree, Merrill, Wanzeler, Labriola, Craft, Costa, the Insider  
13 Promoter Does and others knew, or in the exercise of reasonable diligence, should have known,  
14 of the untruths and omissions.

15 420. Plaintiffs would not have purchased the securities if they had this knowledge.

16 421. As a result of these investments, Plaintiffs have been damaged.

17 422. Plaintiffs are entitled to rescind their purchases and recover the value of their  
18 interest in TelexFree. Plaintiffs seek rescission of their purchase of membership interests in  
19 TelexFree.

20 **SIXTH CLAIM FOR RELIEF**

21 **(FOR VIOLATIONS OF MASSACHUSETTS GENERAL LAWS, CHAPTER**  
22 **110A, SECTION 410(A) AGAINST DEFENDANTS TELEXFREE, MERRILL,**  
23 **WANZELER, LABRIOLA, CRAFT, COSTA, RODRIGUES, DE LA ROSA, CROSBY,**  
**AND SLOAN)**

24 423. Plaintiffs incorporate by reference the allegations contained in Paragraphs 1 - 422  
25 as if fully restated herein.

26 424. During the Class Period, Defendants Defendants TelexFree, Merrill, Wanzeler,  
27 Labriola, Craft, Costa, the Insider Promoter Does and others offered and sold securities to the  
28

1 Plaintiffs by means of a scheme and a continuous course of conduct to make materially false and  
2 misleading statements about the TelexFree investment dealings, financial condition and  
3 operations and to conceal adverse material information about these investments.

4 425. Said Defendants employed devices, schemes, and artifices to defraud, while in  
5 possession of material adverse non-public information and engaged in acts, practices, and  
6 courses of conduct, as alleged herein, including the following: (1) making or participating in the  
7 making of untrue statements of material facts; (2) omitting to state the material facts necessary to  
8 make the statements about the investments not misleading; and (3) engaging in transactions,  
9 practices, and a course of business which operated as a fraud and deceit upon investors during  
10 the Class Period.

11 426. Each of the said Defendants offered and sold securities by means of fraudulent  
12 misrepresentations and intentional omissions of material facts concerning the securities.

13 427. Defendants had actual knowledge of the misrepresentations and omissions of  
14 material facts set forth herein, or acted with reckless disregard for the truth in that they failed to

8 Massachusetts Uniform Securities Act, M.G.L. c. 110A, and Plaintiffs have been damaged  
9 thereby, in an amount to be proven at trial.

10 **SEVENTH CLAIM FOR RELIEF**

11 **(FOR VIOLATIONS OF MASSACHUSETTS GENERAL LAWS, CHAPTER**  
12 **110A, SECTION 410(B) AGAINST DEFENDANTS MERILL, WANZELER, LABRIOLA,**  
13 **CRAFT, CRAFT FINANCIAL, COSTA, NEHRA, LAW OFFICES OF NEHRA AND**  
14 **WAAK, AND GERALD P. NEHRA, ATTORNEY AT LAW, PLLC, AND OTHERS)**

15 434. Plaintiffs incorporate by reference the allegations contained in Paragraphs 1 - 434  
16 as if as fully restated herein.

17 435. At the time of the wrongs alleged herein, Defendants Merrill, Wanzeler, Labriola,  
18 Craft, Craft Financial, Costa, Waak, Nehra, Law Offices of Nehra and Waak, Gerald P. Nehra,  
19 Attorney at Law, PLLC, and others were each a controlling person, partner, officer, director,  
20 person occupying a similar status, or employee materially aiding in the sale of securities, of  
21 TelexFree within the meaning of Section 410(b) of the Massachusetts Uniform Securities Act,  
22 M.G.L. c. 110A.

23 436. By reason of their respective positions of authority, Merrill, Wanzeler, Labriola,  
24 Craft, Craft Financial, Costa, Waak, Nehra, Law Offices of Nehra and Waak, Gerald P. Nehra,  
25 Attorney at Law, PLLC, and others had the power and authority to influence and control, and did  
26 influence and control, the decision-making and activities of TelexFree and the affiliated  
27 TelexFree entities and caused them to engage in the wrongful conduct described herein.  
28 Defendants Merrill, Wanzeler, Labriola, Craft, Craft Financial, Costa, Waak, Nehra, Law Offices

1 of Nehra and Waak, and Gerald P. Nehra, Attorney at Law, PLLC exercised control to cause the  
2 dissemination of false and misleading statements and omissions of material facts.

3 437. By virtue of their positions as controlling person and top-level promoters, and as a  
4 result of the aforementioned conduct, Defendants are liable under Section 20(a) of the Exchange  
5 Act.

6 438. Plaintiffs seek the award of actual damages on behalf of the Class.

7 **EIGHTH CLAIM FOR RELIEF**

8 **(NEGLIGENCE AGAINST ALL DEFENDANTS)**

9 439. Plaintiffs incorporate by reference the allegations contained in Paragraphs 1 - 438  
10 as if fully restated herein.

11 440. At all times material herein, Defendants owned a duty to Plaintiffs to act with a  
12 level of care to avoid misstating TelexFree's financial information or its returns; and to comply  
13 with all applicable laws concerning TelexFree, including, without limitation, federal and state  
14 securities laws.

15 441. By virtue of misstating and omitting relevant financial information, including the  
16 returns to Promoter/Investors, TelexFree breached its duty of care owed to Plaintiffs, the Putative  
17 Class Plaintiffs and similarly situated Plaintiffs.

18 442. As a direct and proximate result of Defendants' negligence and carelessness,

20 and sustain damages and losses.

27 444. Defendants, TelexFree, Merrill, Wanzeler, Labriola, Craft, Craft Financial, Costa,

1 others, directly and through their agents, servants, employees and/or representatives, did  
2 negligently make false representations of material fact to the said Plaintiffs, with said

9 447. In consequence of said reliance on the negligent misrepresentations, the said  
10 Plaintiffs have suffered great financial losses, and have also incurred considerable expenses and  
11 loss of income, and have otherwise been greatly damaged.

26 451. Said representations and statements were material and were relied upon by the  
27 said Plaintiffs, inducing them to furnish money to Defendants.

1 452. In consequence of said reliance on the intentional misrepresentations, the said  
2 Plaintiffs have suffered great financial losses, and have also incurred considerable expenses and  
3 loss of income, and have otherwise been greatly damaged.

14 455. The said Defendants had a duty to perform these services in conformance with the  
15 skill and knowledge normally possessed by members of the accounting and legal professions,  
16 using good, known, and accepted customs and practices of the these professions.

17 456. The said Defendants breached their duty to Plaintiffs by negligently certifying and  
18 representing to Plaintiffs and the public that the business model and operations of TelexFree  
19 were legal, proper, and economically viable and sustainable, when in fact TelexFree's business  
20 model and operations constituted an illegal and unsustainable Ponzi scheme.

21 457. The said Defendants further failed to exercise proper due diligence in the  
22 discharge of their investigatory duties as certified public accountants and attorneys of TelexFree.

23 458. Furthermore, Defendants Craft and Craft Financial negligently failed to ensure  
24 that TelexFree maintained proper accounting records.

25 459. As a result of the professional negligence of said Defendants, Plaintiffs and the  
26 public were misled to belief that TelexFree were legal, proper, and economically viable and  
27 sustainable.

28 460. As a direct and proximate consequence of the aforementioned negligence of the  
said Defendants, Plaintiffs sustained injuries and losses.

**TWELFTH CLAIM FOR RELIEF**

463. The said Defendants violated their duty by actively misrepresenting and fraudulently failing to convey facts material to the TelexFree AdCentral investment packages, including:

- (a) Providing false and misleading information as to the nature of TelexFree business operation;
- (b) Misrepresenting the financial statements;
- (c) Providing false and misleading information as to the value of the AdCentral Package;
- (d) Providing false and misleading information as to the method and source from which income was derived;
- (e) Providing false and misleading information as to the legality of TelexFree's business model;
- (f) Providing false and misleading information as to the sustainability of the returns to Promoter/Investors;
- (g) Providing false and misleading information regarding the investigation in Brazil and subsequent closure of TeleFree's Brazilian operations,
- (h) Knowingly participating in false and deceptive information televised over the internet and other media;
- (i) Concealing the fact that the AdCentral Packages were actually securities;
- (j) Failing to comply with federal and state securities laws; and
- (k) Employing legal and accountant counsel to mask their illegal and fraudulent activities in an effort to further and perpetuate such illegal fraudulent activities.

16 loyalty to Plaintiffs.

17 470. As a result of the foregoing breach of fiduciary duty by Defendants, Investors  
18 paid artificially inflated prices for worthless membership interests in the investment during the  
19 Class Period.

4 473. Defendants violated their duty by actively misrepresenting and fraudulently  
5 failing to convey facts material to the TelexFree AdCentral investment packages, including:

- 6 (a) Providing false and misleading information as to the nature of TelexFree business  
7 operation;
- 8 (b) Misrepresenting the financial statements;
- 9 (c) Providing false and misleading information as to the value of the AdCentral

21 483. Said Defendants have unlawfully and in bad faith denied Plaintiffs access to such  
22 funds, and have instead retained the benefit of such funds for themselves.

23 484. As a direct and proximate result of the foregoing actions of Defendants, as  
24 hereinabove set forth, the said Defendants are, and continue to be, unjustly enriched.

18 493. The ongoing fraudulent scheme described herein could not have been perpetrated  
19 over a substantial period of time, without the knowledge and complicity of Defendants.

20 494. As a result of the foregoing fraud perpetrated by Defendants, Investors paid  
21 artificially inflated prices for worthless membership interests in the investment during the Class  
22 Period.

23 **SIXTEENTH CLAIM FOR RELIEF**

5 497. Defendants rendered such substantial assistance despite their knowledge that  
6 TelexFree's operations constituted an illegal and unsustainable pyramid Ponzi scheme and  
7 financial fraud.

8 498. Such substantial assistance rendered by said Defendants despite their knowledge  
9 of the fraudulent nature of TelexFree's operations, include, *inter alia*:

- 10 (a) Managing and controlling TelexFree and its affiliated entities;
- 11 (b) Providing accounting services to TelexFree;
- 12 (c) Providing legal services to TelexFree;
- 13 (d) Publicly certifying that TelexFree's business model and operations were  
14 legal, proper, and economically viable and sustainable;
- 15 (e) Providing banking services for TelexFree and its management;
- 16 (f) Promoting TelexFree AdCentral packages;
- 17 (g) Processing payments to, from, and on behalf of TelexFree and its affiliated  
18 entities; and
- 19 (h) Process payments for transfers of funds which deepened TelexFree's  
20 insolvency.

21 499. As a direct and proximate result of TelexFree's fraud, to which the said

7 Plaintiffs.

8 504. More particularly, such transfers were made in an attempt to dissipate, convert  
9 and conceal funds that are lawfully due to Plaintiffs.

10 505. As a result of such fraudulent transfers, Plaintiffs have suffered, or will  
11 imminently suffer, damages and losses.

12 **EIGHTEENTH CLAIM FOR RELIEF**

26 510. Such transfers have greatly decreased the probable extent of recovery by Plaintiff  
27 creditors.

1 511. As a result of such fraudulent transfers, Plaintiffs have suffered, or will  
2 imminently suffer, damages and losses.

15 **TWENTY-SECOND CLAIM FOR RELIEF**

16 **(FOR VIOLATIONS OF THE RACKETEER INFLUENCED AND CORRUPT**  
17 **ORGANIZATIONS ACT, UNITED STATES CODE, TITLE 18, SECTION 1962**  
18 **AGAINST DEFENDANTS TELEXFREE, TELEXELECTRIC, TELEX MOBILE,**  
19 **MERRILL, WANZELER, LABRIOLA, CRAFT, CRAFT FINANCIAL, COSTA,**  
20 **NEHRA, WAAK, LAW OFFICES OF NEHRA AND WAAK, GERALD P. NEHRA,**  
21 **ATTORNEY AT LAW, PLLC, RICHARD W. WAAK, ATTORNEY AT LAW, PLLC, TD**  
22 **BANK, CITIZENS FINANCIAL, CITIZENS BANK, FIDELITY BANK, MIDDLESEX**  
23 **SAVINGS, GPG, IPS, PROPAY AND THE DOE DEFENDANTS)**

24 524. Plaintiffs incorporate by reference the allegations contained in Paragraphs 1 - 523  
25 as if fully restated herein.

26 525. At all times material herein, Defendants TelexFree, TelexElectric, Telex Mobile,  
27 Merrill, Wanzeler, Labriola, Craft, Craft Financial, Costa, Nehra, Waak, Law Offices of Nehra  
28 and Waak, Gerald P. Nehra, Attorney at Law, PLLC, and Richard W. Waak, Attorney at Law,  
PLLC, TD Bank, Citizens Financial, Citizens Bank, Fidelity Bank, Middlesex Savings, GPG,  
IPS, ProPay and the Doe defendants were associated in an enterprise as defined by 18 U.S.C.  
1961(4).

1 526. Such enterprise was engaged in unlawful and illegal activities, including, *inter*  
2 *alia*, securities fraud and financial fraud, as set forth more fully throughout this Complaint, and  
3 which made use of the means and instrumentalities of interstate commerce and which crossed  
4 jurisdictional lines.

5 527. Throughout their involvement with such enterprise, the said Defendants engaged  
6 in a pattern of securities fraud, financial fraud, and other illegal and wrongful behavior,  
7 comprising numerous instances of such illegal and wrongful behavior.

8 528. Such illegal and wrongful behavior constitutes “racketeering activity” as defined  
9 by 18 U.S.C. 1961(1).

10 529. The said Defendants were aware of the illegal and fraudulent nature of the  
11 enterprise.

12 530. The said Defendants each actively participated in the enterprise and its pattern of  
13 racketeering activity.

14 531. The said Defendants each received income, directly or indirectly, as a result of the  
15 enterprise and its pattern of racketeering activity.

16 532. The said Defendants did further conspire to engage in such pattern of racketeering  
17 activity.

18 533. In consequence of the said Defendants’ unlawful enterprise and pattern of  
19 racketeering activity Plaintiffs have suffered great financial losses, and have also incurred  
20 considerable expenses and loss of income, and have otherwise been greatly damaged.

21 **TWENTY-THIRD CLAIM FOR RELIEF**

22 **(FOR VIOLATIONS OF THE LANHAM ACT, UNITED STATES CODE, TITLE 15,**  
23 **SECTION 1125 AGAINST DEFENDANTS TELEXFREE, MERRILL, WANZELER,**  
24 **LABRIOLA, CRAFT, CRAFT FINANCIAL, COSTA, WAAK, NEHRA, LAW OFFICES**  
**OF NEHRA AND WAAK, GERALD P. NEHRA, ATTORNEY AT LAW, PLLC)**

25 534. Plaintiffs incorporate by reference the allegations contained in Paragraphs 1 - 534  
26 as if fully restated herein.

27  
28

1 535. As set forth more particularly throughout this Complaint, and in direct violation  
2 of the Lanham Act, 15 U.S.C. § 1125, the Defendants TelexFree, Merrill, Wanzeler, Labriola,  
3 Craft, Craft Financial, Costa, Waak, Nehra, Law Offices of Nehra and Waak, and Gerald P.  
4 Nehra, Attorney at Law, PLLC have used false or misleading descriptions of material fact, and  
5 false and/or misleading representation of material fact, in promoting and selling TelexFree's  
6 AdCentral investment packages and VoIP products.

7 536. In so doing, Defendants made use of the means and instrumentalities of interstate  
8 commerce and crossed jurisdictional lines.

9 537. Said Defendants have also used false and/or misleading descriptions of material  
10 fact, and false or misleading representations of material fact, in characterizing the nature of  
11 TelexFree's business operations, returns on investment, and the legality of the investments.

12 538. Said Defendants' false and/or misleading descriptions of material fact, and false  
13 or misleading representations of material fact, did actually deceive, or have the tendency to  
14 deceive, both Plaintiffs and the public.

15 539. As direct and proximate result of the false and misleading advertisements  
16 disseminated by Defendants, Investors paid artificially inflated prices for worthless membership  
17 interests in the investment during the Class Period.

18 **CONCLUSION**

19 WHEREFORE, Plaintiffs, on behalf of themselves and the Class, pray for judgment as  
20 follows:

21 1. Declaring this action to be a Class Action properly maintained pursuant to the  
22 Federal Rules of Civil Procedure and certifying Plaintiffs as the class representatives;

23 2. Awarding Plaintiffs and Class members rescission and/or compensatory damages  
24 against Defendants for all damages sustained as a result of their wrongdoing, in an amount to be  
25 proven at trial, including interest;

26 3. For an award of actual damages, compensatory damages, statutory damages, and  
27 statutory penalties, in an amount to be determined;

28

- 1 4. For an award of punitive damages;  
2 5. For an award of costs of suit and attorneys' fees, as allowable by law;  
3 6. For an award of interest;  
4 7. For the appointment of a receiver selected by Class Counsel and an accounting;  
5 and  
6 8. For an award to Plaintiffs and the Class such other and further relief as may be  
7 just and proper under the circumstances including equitable relief.


8 **DEMAND FOR JURY TRIAL**
