**MOTION FOR ENTRY OF DEFAULT**

Stephen B. Darr, as he is the Trustee (the "Trustee") of the Chapter 11 estates of TelexFree, LLC, TelexFree, Inc., and TelexFree Financial, Inc. (collectively, the "Debtors"), moves pursuant to Rule 55(a) of the Federal Rules of Civil Procedure, as incorporated herein by Rule 7055 of the Rules of Bankruptcy Procedure, that the Defendant Opt 3 Solutions, Inc. ("Opt 3") be defaulted for failure to answer or otherwise defend this action.



In support of his motion, the Trustee states that the Defendant Opt 3 was served with a copy of the Summons and the Complaint, and has failed to defend.<sup>1</sup> In further support, the Trustee relies on the Affidavit of Andrew G. Lizotte, Esquire, annexed hereto as Exhibit A.

On December 2, 2016, the Trustee moved for default against Opt 3, serving Opt 3 at the address upon which service of the Complaint and Summons was made. The motion was denied on December 20, 2016 without prejudice for failure to properly serve the defendant. The Trustee has been provided by Opt 3's principal with an alternative mailing address. An updated certificate of service is attached hereto.

WHEREFORE, the Stephen B. Darr, as he is the Trustee of the Chapter 11 Estates of TelexFree, LLC, TelexFree, Inc., and TelexFree Financial, Inc., respectfully prays that his Motion be allowed and that this Court enter an order defaulting Opt 3.

I, Andrew Lizotte, being duly sworn, depose and state that:

1. I am a member of the law firm of Murphy & King, which law firm is counsel to Stephen Darr, as he is the Chapter 11 Trustee (the "Trustee") of TelexFree, LLC, TelexFree, Inc., and TelexFree Financial, Inc. (the "Debtors"). I am making this affidavit based upon my personal knowledge except with respect to those statements made on information and belief, and as to those statements, I believe them to be true based upon the books and records of the Debtors.

2. On April 5, 2016, the Trustee commenced this action by filing the Complaint.

3. On or about April 5, 2016, I caused a copy of the Summons and Complaint to be mailed, by first class mail and certified mail – return receipt requested, upon the Defendant Opt 3 Solution, Inc. (“Opt 3”) at 120 Vantis, Suite 300, Aliso Viejo, CA 92656.

4. On May 4, 2016, I filed a certificate of service attesting that Opt 3 was successfully served with the Complaint and Summons by certified mail.

5. As a result of a series of motions to extend time to file answer, the deadline for Opt 3 to submit a responsive pleading expired on August 17, 2016.

6. The docket reflects that no responsive pleading has been filed.

7. Jay Borrromei, the co-Defendant and principal of Opt 3, filed a Chapter 7 bankruptcy petition in the Central District of California on September 13, 2016. Mr. Borrromei filed a Suggestion of Bankruptcy with this Court on September 20, 2016 and the matter is stayed as to Borrromei.
