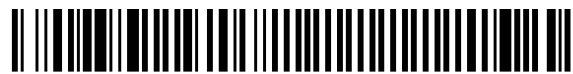


1 The Court, having reviewed the application (“Application”) filed as Docket Number 484 by
