PLEASE TAKE FURTHER NOTICE THAT, IF NO WRITTEN RESPONSE IS FILED BY THE RESPONSE DEADLINE, THE RELIEF REQUESTED BY THE OBJECTION SHALL BE DEEMED TO BE UNOPPOSED, AND THE COURT MAY ENTER AN ORDER GRANTING THE RELIEF SOUGHT WITHOUT A HEARING THEREON.
